**Child Care and Development Fund (CCDF) Program
 announces grant applications for licensed center base child care programs and
 services under the Cares Act funding.**

Grants are currently being offered to Licensed-center base child care providers to address needs related to program operations, health and safety, and improving quality child care services during the Covid 19 Pandemic. Eligible proposals may receive a one-time grant of up to \$25,000.00 per site/location. CCDF has the right to award smaller grant awards as appropriate and as recommended by the CCDF Grant Review Committee.

Who can apply?: All Licensed center based child care programs.

How can I apply?: Complete the Cares Funds Part III CCDF Grant Application and submit with related documents.


When should I apply?: Applications will be available beginning April 1, 2021. Completed applications, along with documentations should be received by the CCDF Program Office on or before April 30, 2021 at 3:00p.m. Incomplete applications will not be reviewed and returned.


Where can I get the application?:

- Hard copy may be picked up from the CCDF Office Bldg. 1347 Capitol Hill, Saipan between 8:00a.m. to 4:00p.m. CCDF Office is open during lunch hour.

Only written inquiries will be entertained. Submit all inquiries to mloste.cnicccdf@gmail.com on or before April 20, 2021. Inquiries submitted after the deadline will not be entertained. Responses to the inquiries will be emailed no later than April 26, 2021 to all who picked up the grant application as well as posted in the CCLP website: cnicclp.gov.mp.
