SUBJECT: Draft Memorandum on Pacific Islands Territories

Thank you for letting me see the proposed memorandum to the Secretary from Governor Harriman.

I have only two suggestions:

1. In the summary of conclusion of the November 26-29, 1962 meeting, it seems to me that the order of points might be changed-- as I have indicated by pencilled numbers.

2. In the covering memorandum a reference might be made to the NSC Task Force on the Trust Territory of the Pacific Islands- possibly under point (3) in the final paragraph. Also consideration might be given to adding to point (3) some such clause as "and possibly planning of tentative time tables for political transition."
