SUBJ: TRUSTEESHIP COUNCIL: TTPI

ANDERSON LEARNED FROM BROOKS (LIBERIA) THAT LATTER WOULD BE MAKING A FEW REMARKS JULY 1. REMARKS WOULD ALSO INCLUDE INTRODUCTION OF RES ON WHO REPORT. WHEN ASKED WHAT RES WOULD CONTAIN BROOKS REPLIED VAGUELY THAT IT WOULD NOTE WHO REPORT AND CALL ON US TO IMPLEMENT RECS.

ANDERSON APPROACHED AUSTRALIA, UK, FRENCH AND LIBERIAN DELS RE THEIR PARTICIPATION ON VISITING MISSION TO TTPI IN 1967. ALL FOUR WERE FAVORABLE IN THEIR RESPONSE AND WILL SEEK INSTRUCTIONS FROM THEIR GOVERNMENTS. DISCUSSION THEN REVOLVED AROUND POSSIBILITY OF SENDING EXPERTS WITH M. BROWN (UK) SUGGESTED THERE BE TWO MEMBERS OF TC AND POSSIBLY TWO EXPERTS ON MISSION. BROOKS AND MCCARTHY (AUSTRALIA) FELT IT BEST ALL FOUR TC MEMBERS BE ON VM WITH NO MORE THAN ONE EXPERT. ANDERSON SAW NO OBJECTION TO EXPERTS BEING ON VM BUT THOUGHT ONLY ONE WOULD BE NECESSARY.

COMMENT: INTRODUCTION OF RES ON WHO BY BROOKS IS WELCOMED AND WILL PROBABLY BE LESS CRITICAL THAN ONE THAT COULD BE INTRODUCED BY USSR. TO DATE, USSR PERFORMANCE HAS BEEN LACKLUSTER AND INTERVENTIONS HAVE BEEN RELATIVELY MILD AS COMPARED WITH PREVIOUS SESSIONS. IN VIEW OF THIS IT POSSIBLE USSR WOULD ONLY ATTEMPT TO AMEND A RES INTRODUCED BY ANOTHER DEL.

RE EXPERT SERVING ON VISITING MISSION, BELIEVE THIS GOOD IDEA WHICH COULD SERVE USEFUL PURPOSE, AND THEREFORE SHOULD BE SUPPORTED.
