1. DEPARTMENT OF TERRITORIES STATT THAT

DISTRICT ADMINISTRATOR NAURU HAS RECEIVED MESSAGE FROM DWIGHT HEINE, DISTRICT ADMINISTRATOR TTPI, REQUESTING PERMISSION ENTRY NAMELY FOR HIMSELF 10 MEMBERS DISTRICT STAFF PLUS SOME MEMBERS HICOM STAFF IN EARLY OCTOBER VIA TTPI GOVERNMENT VESSEL. STATED PURPOSE VISIT "COURTESY CALL AND EXPLORE IDEAS OF MUTUAL INTEREST TO NEIGHBORING ISLANDS." NO INDICATION GIVEN LENGTH OF STAY.

2. BEFORE APPROVING SUCH VISIT, DEPARTMENT OF TERRITORIES WANTS FURTHER INFORMATION PURPOSE

PAGE TWO RUHDAC 1403 UNCLAS OF VISIT AND INTENDED LENGTH OF STAY. ALSO DISTRICT ADMINISTRATOR POINTS OUT THAT NAURU ACCOMMODATIONS INADEQUATE FOR ENTIRE GROUP. DEPARTMENT OF TERRITORIES SUSPECTS PRIMARY PURPOSE VISIT IS FOR CONVERSATIONS WITH CHIEF HAMMER DE ROBERT WHO WILL NOT BE IN NAURU EARLY OCTOBER.
