MEMORANDUM FOR THE SECRETARY OF DEFENSE

SUBJECT: Cleanup of Bikini Atoll by DOD/AEC, Requirement Based on Military Interest (U)

1. (C) Reference is made to a memorandum by the Acting Assistant Secretary of Defense (ISA), I-15359/68, dated 23 December 1968, subject as above, which:

a. Forwarded your request for a memorandum setting forth the military interests involved;

b. Requested my comments on a proposal that DOD and AEC jointly assume the task of cleaning up the Bikini Atoll and that \$300,000 of the FY 1969 DOD Contingency Fund be expended for this purpose.

2. (C) The primary military interest involved in the cleanup of Bikini Atoll is in moving the Trust Territory of the Datilic Islands (TTPI), of which this atoll is a part, intera permanent relationship within the political framework of the United States. The interest of the Joint Chiefs of Staff in such a permanent relationship was presented to you in JCSM 643-68, dated 31 October 1968, subject, "Strategic Importance of the Trust Territory of the Pacific Islands (U)." In that paper it was pointed out that a permanent US-TTPI relationship would contribute to US ability to monitor and control the sea and air space of the Pacific Ocean area and counter communist strength in the forward Asian-Pacific regions. Failure or delay in restoring the atoll to habitable condition could disaffect the natives involved, further complicating US difficulties in moving the TTPI into the desired permanent relationship.
