1. COMMISSION HAS ALTERED ITINERARY AND WILL ARRIVE MANILA EARLIER THAN ORIGINALLY PLANNED. WE UNDERSTAND GROUP WILL DEPART PORT MORESBY FOR MANILA MARCH 27 VIA QANTAS AND WILL DEPART MANILA FOR OKINAWA MARCH 31. WE WILL TRANSMIT FLIGHT DETAILS EARLY NEXT WEEK.

2. PARTY COMPOSITION IS SLIGHTLY DIFFERENT THAN ORIGINALLY REPORTED. IN ADDITION SIX COMMISSION MEMBERS AND STAFF OFFICER CARL HEINE ALREADY REPORTED, COMMISSION ACCOMPANIED BY THREE MICRONESIAN BUSINESSMEN: MR. ATLAN ANIEN (IN PLACE OF DAVID SABLAN, WHO IS NOT RPT NOT WITH GROUP), MR. ISIDORO RUDIMCH, AND MR. JOSE C. TINORIO.

3. COMMISSION REQUESTS EMBASSY RESERVE FIVE DOUBLE ROOMS IN MANILA HOTEL.
