SUBJ: TRUSTEESHIP COUNCIL CONSIDERATION OF TTPI

1. TRUSTEESHIP COUNCIL MET JUNE 8 P.M. TO CONSIDER PETITIONS AND PETITIONERS RELATING TO TTPI. MEETING ORIGINALLY SCHEDULED FRIDAY, JUNE 5, BUT POSTPONED DUE INABILITY PETITIONER FREEMAN TO APPEAR.
2. STUDENT VILLANUEVA QUESTIONED PRESENT US ADMINISTRATION (SPECIFICALLY, MILITARY RETENTION LANDS, LAND CADASTER PROGRAM AND FISCAL DEPENDENCE OF US) PREJUDGING FUTURE OF TTPI AND EXPRESSED HOPE UN PARTICIPATE DIRECTLY IN DETERMINING FUTURE. ALSO URGED MORE FREQUENT VISITS TO MICRONESIA BY MEMBER STATES INCLUDING USSR TO COUNSEL PEOPLE MICRONESIA ON RIGHTS.
3. FREEMAN SAID IN RESPONSE TO QUESTION FROM UK REP HE ACTING AND APPEARING AS ATTORNEY FOR MICRONESIAN PEOPLE. (REP MANGLONA ALSO IN RESPONSE QUESTION UK REP SAID HE UNAWARE IF LEADERSHIP CONGRESS MICRONESIA HAD ASKED FREEMAN TO REPRESENT PEOPLE BEFORE COUNCIL.)

4. FREEMAN STATEMENT SAID HE WISHED TO SECURE INTEREST AND INVOLVEMENT OF UN IN MICRONESIA'S MOVE TOWARD SELF-DETERMINATION. FOUR MAJOR QUESTIONS NEED BE DECIDED: A) THEORY OF TRUSTEESHIP -- I. E. WHETHER US REALLY ACTING PROPERLY AS TRUSTEE PUTTING INTERESTS OF MICRONESIANS FIRST. FREEMAN SAID BOTH US AND JAPAN HAD VIOLATED THIS OBLIGATION. B) LAND - TWO-THIRDS LAND NOW UNDER US CONTROL. AT SELF-DETERMINATION ALL MUST BE RETURNED MICRONESIANS. SAID US APPLYING ITS STANDARDS TO TERRITORIAL WATERS QUESTION INSTEAD OF MICRONESIAN POSITION WHICH ADVOCATES ARCHIPELAGO THEORY. SPECULATED US WISHED ENFORCE THREE OR TWELVE MILE TERRITORIAL SEA IN TTPI IN ORDER UTILIZE SHALLOW WATERS BEYOND LIMIT FOR EMPLACEMENT NUCLEAR WEAPONS ON SEABED. C) CLAIMS - ALL TYPES AGAINST US AND JAPAN TOTALLING PROBABLY BETWEEN \$1 AND \$4 BILLION. US VIOLATED TRUST BY ENTERING AGREEMENT WITH JAPAN. FREEMAN ALSO STATED MONEY SHOULD BE GIVEN DIRECTLY TO MICRONESIAN GOVERNMENT FOR DISBURSEMENT, NOT HANDLED BY US LEGISLATION. D) MILITARY QUESTIONS - MICRONESIANS DID NOT FEEL US BASES WERE IN INTERESTS WORLD SECURITY. THEY DO NOT WISH TO BECOME A TARGET (PEARL HARBOR OF WORLD WAR III) AND FEARED TRANSFER US INSTALLATIONS FROM OKINAWA. FREEMAN SAID COUNCIL SHOULD BE ALERT SINCE US MAY INTEND MAKE TTPI ITS WESTERN LINE OF DEFENSE.

5. FREEMAN SAID FOR PRESENT HE ONLY WANTED UN CONCERN. BUT MICRONESIANS FIND THEMSELVES IN UNEQUAL POSITION IN NEGOTIATING WITH US. MAY WISH CONSULT WITH COUNCIL AND OTHER APPROPRIATE UN ORGANS. ALSO MIGHT WISH APPROACH INTERNATIONAL COURT OR UN FOR INTERPRETATION OF TRUSTEESHIP AGREEMENT.

6. ONLY FRANCE AND UK REPS ASKED QUESTIONS - FRANCE REGARDING LEGAL STATUS OF LAND AND UK FOR EXAMPLES US VIOLATIONS OF TRUST. IN RESPONSE TO LATTER QUESTION, FREEMAN CITED AS EXAMPLE IN ADDITION MILITARY ACTIVITIES, SMALL BUDGET, LACK TRAINING IN SELF-GOVERNMENT, OTHER LAND TAKINGS.

7. IN DISCUSSION PETITIONS AND COMMUNICATIONS ONLY SOVIET REP ASKED QUESTIONS. ACTUALLY ONLY THREE RELATED TO WRITTEN DOCUMENT- ONE ON BIKINI, ONE ON ADMINISTRATION RESPONSIVENESS TO APAPLAU LEGISLATURE AND ONE ON PLANS FOR MILITARY BASES.

HICOM CITED RECORD ON BIKINI AND MORE RECENT PALAU RESOLUTION OF COMMENDATION. AMB WRIGHT SAID NO IMMEDIATE PLANS FOR MILITARY BASES, BUT CITED US RIGHTS UNDER TRUSTEESHIP AGREEMENT. SOVIET REP THEN ASKED FIVE QUESTIONS RE PETITIONEERS STATEMENTS. NONE DEALT WITH MILITARY QUESTIONS AND ONLY ITEM ON FUTURE RELATED TO DISPOSITION OF LAND. AMB WRIGHT SAID GENERALLY LAND WOULD GO TO MICRONESIANS BUT SOME SPECIFIC ARRANGMENTS MIGHT BE HANDLED IN STATUS TALKS (RECORD OF SESSION FOLLOWS BY AIRMAIL/POUCH).
