RECRUITED TO DIRECT THE OPERATION OF THIS CORPORATION IS THEODORE MITCHELL OF WINDOW ROCK, ARIZONA. A DELEGATION FROM MICRONESIA CONSISTED OF SENATOR EDWARD PANGELINAN OF THE CON-GRESS OF MICRONESIA, HERMAN GUERRERO, PRESIDENT OF THE MICRONE-

SIA LEGAL SERVICE CORPORATION AND MAMORU NAKAMURA, TT GENERAL ATTORNEY, WENT TO SAN FRANCISCO LAST WEEK TO ANNOUNCE THE SELECTION OF MITCHELL AS THE NEW DIRECTOR OF THIS CORPORATION.

MITCHELL, FORMERLY DIRECTOR OF A NAVAJO INDIAN LEGAL SERVICE PROGRAM (DNA), WAS CHOSEN FROM AMONG 300 APPLICANTS FROM A NATIONWIDE RECRUITMENT PROGRAM. HE IS A GRADUATE OF HARVARD LAW SCHOOL.

MITCHELL, 35, STEPPED DOWN FROM THE TOP PROGRAM OFFICIAL OF DNA WHEN A NAVAJO BECAME CAPABLE OF ASSUMING THE POST. HE WILL BE RESPONSIBLE FOR THE OEO LEGAL SERVICE PROGRAM IN THE TT WHICH IS INTENDED TO REPRESENT POOR PEOPLE IN ALL PHASES OF CIVIL LEGAL PROBLEMS AS WELL AS MOTIVATING YOUNG MICRONESIANS TO BECOME LAWYERS.

THIS PROGRAM WILL BE HEADQUARTERED AT SAIPAN, SEAT OF THE TT GOVERNMENT. LEGAL SERVICE PROGRAM OFFICES ALSO WILL BE ESTA-BLISHED IN THE OTHER DISTRICT OF THE TT.

TO MAN THIS PROGRAM SEVEN OTHER ATTORNEYS WILL BE HIRED TO ASSIST MITCHELL. ALSO SIX MICRONESIANS WILL BE RECRUITED AS "LEGAL ASSISTANTS."

MITCHELL SAID, "A UNIQUE FEATURE OF THE PROGRAM IS THAT

MILI ENTERED INTO AN AGREEMENT WITH THE TT GOVERNMENT ON AUGUST 31, 1968, TO DO SHIPPING BUSINESS FOR THE TT.
