SUBJ: FUTURE POLITICAL STATUS - COMMUNICATIONS BETWEEN SENATOR
SALII AND AMBASSADOR WILLIAMS

1. SENATOR SALII TOLD ME MAY 21 WHAT HE SHORTLY WILL BE WRITING TO AMBASSADOR WILLIAMS CONCERNING STATUS DEVELOPMENTS HERE, INCLUDING NEW DECISIONS TAKEN BY STATUS COMMITTEE WHICH HAVE BEEN REPORTED SEPARATELY. PRESUMEABLY THERE WILL BE SOME DISCUSSION OF VENUE AND TIMING OF TALKS.
2. SALII QUITE RIGHTLY HOLDS THAT ANY RELEASE TO ME OF COMMUNICATIONS BETWEEN HIMSELF AND AMBASSADOR WILLIAMS SHOULD BE BY LETTER. HE STATES HE HAS NO OBJECTION TO SUCH ACTION,
3. WHILE MOST CERTAINLY I CLAIM NO RIGHT TO BE PRIVILEGED TO SUCH

CORRESPONDENCE, IT WOULD BE MOST HELPFUL IF COPIES COULD BE PROVIDED TO ME. IT COULD BE SINGULARLY IMPORTANT WITH RESPECT TO BEING ABLE TO HELP INTERPRET NUANCES OF STATEMENTS AND EVENTS HERE, PARTICULARLY THOSE INVOLVING SALII AND STATUS COMMITTEE. BETTER YET, IT WOULD HELP AND IMPROVE MY OWN SOMEWHAT DIFFICULT POSITION IF AMBASSADOR WILLIAMS' LETTERS COULD BE TRANSMITTED TO SALII VIA MYSELF. IT MAY SOUND A SMALL THING, BUT ANYTHING THAT CAN BE DONE TO PROMOTE A CLOSE AND ESSENTIAL RELATIONSHIP WITH SALII HELPS IN TERMS MY OVERALL REPORTING FUNCTION.
