"THE TWO GROUPS ARRIVED IN HAMA OCTOBER 3 AND NEGOTIATIONS BEGAN THE FOLLOWING DAY. AMBASSADOR WILLTAMS WOULD NOT PREDICT HOW LONG THE MEETINGS WILL CONTINUE. THERE WAS NO FORMAL MEETING SUNDAY, THOUGH POSITION PAPERS WERE BEING PASSED AND BOTH GROUPS WERE PREPARING PAPERS FOR MONDAY'S SESSION.
