ATOMIC BOMB ON HIROSHIMA. OF 4,000 ACRES OF "MILITARY RETENTION AREA" ON NEIGHBORING SAIPAN, "MOST" WOULD BE RETURNED. 4. MAJOR SURPRISE WAS NAVY PLANS FOR PALAU DISTRICT. NAVY INTENDS TO CONSTRUCT SUBMARINE BASE AND SHIP HANDLING FACILITIES IN MALAKAL HARBOR, CLOSE TO FAMOUS ROCK ISLANDS. A 40 ACRE H-BOMB AND GAS STORAGE FACILITY AND MARINE GUERILLA TRAINING FACILITY WOULD BE BUILT ON MICRONESIA'S LARGEST ISLAND, BABELTHUAP. IN ADDITION,

SOME AGREEMENT WAS REACHED ON FOUR PRINCIPLES HELD TO BE UNCOMPROMISABLE BY MICRONESIAN DELEGATION, BUT U.S. INTRANSIGENCE ON QUESTION OF TERMINATION PROCEDURES CAUSED MICRONESIAN DELEGATION TO END NEGOTIATIONS. WILLIAMS REFUSED TO DISCUSS AN AGREEMENT THAT WOULD BE TERMINABLE OTHER THAN BY MUTUAL CONSENT. MICRONESIAN THIRD PRINCIPLE DECLARES THAT ANY AGREEMENT MUST BE TERMINABLE UNILATERALLY BY EITHER PARTY SO AS TO GUARENTEE

THAT INVOLVING CONFLICT OF LAW, U.S. AGREED TO ALLOW MICRONESIANS FREEDOM IN CREATING THEIR OWN CONSTITUTION AND LAWS BUT EXPECTED THAT THERE BE BILL OF RIGHTS AND THAT AMERICAN FORM OF GOVERNMENT BE USED AS A MODEL. SENATOR SALII SAID THAT THIS INSULD WAS VIOLATION OF SPIRIT OF NEGOTIATIONS. MICRONESIAN DELEGATION HAS INVITED AMERICANS TO MEET AGAIN 9. IN DECEMBER IN PALAU BUT POSSIBILITY OF THIS IS UNCERTAIN. AS TO FUTURE STEPS THERE ARE TWO POSSIBILITIES, EITHER CONTINUED NEGOTIATIONS OR DECLARATION OF INTENT TO BECOME INDEPENDENT. IN ANY EVENT MICRONESIAN DELEGATION WANTS TO BEING IMMEDIATE INTERNAL REFORM BY CREATING AN ELECTIVE EXECUTIVE TO REPLACE PRESENTLY APPOINTED AMERICAN HIGH COMMISSIONER AND BY GIVING CONGRESS OF MICRONESIA CONTROL OVER APPROPRIATIONS. CONGRESS IS ALSO SECURING SERVICES OF A WASHINGTON LAW FIRM. 10.
