3. SEPARATE SUBJECT. IN SAME CONVERSATION HEINE SAID THAT, THOUGH SUBJECT NOT MENTIONED IN STATUS TALKS, STATUS COMMITTEE HOPES U.S. DELEGATION AT NEXT ROUNDS OF TALKS WILL BE ABLE TO TABLE "MODEL COMPACT." ALSO SAID STATUS COMMITTEE WILL DEFINITELY WANT TO GO INTO "TECHNICAL DETAILS" OF AREAS WHERE THERE IS ALREADY AGREEMENT, AND DISCUSS IN DETAIL POSSIBLE INTERIM TRANSITIONAL STEPS. IN THAT CONNECTION, HE SAID STATUS COMMITTEE MAY PROPOSE A TENTATIVE TIMETABLE FOR TRANSITIONAL STEPS LEADING TO TERMINATION TRUSTEESHIP AGREEMENT.

FINALLY, HEINE SAID (ASSUMING NEXT ROUND OF TALKS TAKES PLACE IN PALAU

ON EVE OF CONGRESSIONAL SESSION) U.S. DELEGATION PROBABLY WILL BE INVITED STAY ON FOR FORMAL OPENING OF SESSION.

4. IN CONNECTION NEXT ROUND OF TALKS, HEINE, UNDER INSTRUCTIONS FROM SALII, IS GOING TO PALAU ON NOVEMBER 8 TO MAKE TENTATIVE HOTEL, OFFICE SPACE, CONFERENCE ROOM AND OTHER ARRANGEMENTS FOR PERIOD DECEMBER 29-JANUARY 15. IN THAT REGARD, HE HAS ASKED ME WHAT U.S. DELEGATION WILL REQUIRE. I TOLD HIM I HAVE NO WORD ON ANY AGREEMENT ON TIMING AND VENUE OF TALKS, BUT ASSUMED U.S. DELEGATION AND SUPPORT PERSONNEL AT NEXT ROUND WOULD BE AT LEAST AS LARGE AS BEFORE. REQUEST EARLY TELEGRAPHIC OR TELEPHONE ADVICE ON THIS POINT.

5. SEPARATE SUBJECT; RE PROBABLE RELEASE HANA TRANSCRIPTS, SALII'S "EXCLUSIVE REPORT" TO FRIENDS OF MICRONESIA (SEE POLAD 55) CERTAINLY PROVIDES ANOTHER AND MAJOR EXCUSE RELEASE TRANSCRIPTS.
