FURTHER, FRIENDS OF MICRONESIA, ULUDONG AND OTHER STATEMENTS AND STORIES DISTORTING US POSITION HAVING AFFECT. MY OWN STATEMENT REBUTTING FRIENDS OF MICRONESIA NEWS RELEASE WAS WELCOMED BY FEW TRUKESE LEADERS I SPOKE WITH WHO WERE AWARE OF EXCHANGE. AT MOMENT IT APPEARS MAIN DAMAGE MAY BE COMING FROM HANS WILLIANDER

3. LONG CONVERSATION I HAD WITH SENATOR NAKAYAMA INDICATED PART OF OUR PROBLEM WITH HIM IS ABSENCE HIS FULL COMPREHENSION OUR VARIOUS STATEMENTS ON LAND AND RELATED ISSUES. HE HAD BEEN ASSUMING OUR REQUIREMENT FOR RECIPROCAL FREE ENTRY OF MICRON-ESIANS AND AMERICANS WOULD MEAN NO MICRONESIAN CONTROL OVER AMERICAN PRIVATE ACQUISITION OF LAND FOR COMMERCIAL PURPOSES, AND OF AMERICAN INVESTMENT AND OTHER ECONOMIC ACTIVITIES. FOR HIM, THIS IS PARTICULARLY BASIC ISSUE. WITH REGARD LAND ISSUE IN TRUK, SO FEW PERSONS ARE AWARE OF DETAILS OF HANA TALKS IT IS DIFFICULT TO GAUGE REACTION LATTER. I DID BRIEF INDIVIDUALS I MET WITH AND THEY SEEMED SURPRISED AND ALMOST UNBELIEVING THAT WE HAVE NO PLANS TURN TRUK LAGOON INTO MAJOR NAVAL BASE. WITHOUT EXCEPTION THERE WAS

4. PONAPE DISTRICT: IN MANY RESPECT PONAPE, WITH YAP, MOST UNINFORMED DISTRICT IN TERRITORY ON ALMOST ANY SUBJECT: THIS BASIC CONDITION AT PRESENT APPLIES TO HANA TALKS: REP. PAUL HAS SAID VIRTUALLY NOTHING TO ANYONE, EXCEPT FOR BRIEF COMMENTS TO A FEW LEADERS EXPRESSING OPTIMISM AND AT SAME TIME HIGHLIGHTING FACT TERMINATION ISSUE REMAINS TO BE RESOLVED: THUS FAR VARIOUS GUAM AND TIPI PRESS ARTICLES ON STATUS TALKS HAVE HAD ONLY VERY MARGINAL IMPACT

AND THEM ONLY ON A VERY FEW PERSONS IN DISTRICT CENTER. AT THIS POINT,

PRESIDENT KABUA) CONSIDERABLE PLEASURE AT PROGRESS MADE AT HANA, BUT ALSO HOMED IN AND PRESSED HARD ON TERMINATION ISSUE: SHORTLY AFTER THEIR RETURN TO MAJURO, THEY ALSO GAVE BRIEF REPORT TO PEOPLE VIA

ON NEGATIVE SIDE, FRIENDS OF MICRONESIA, ULUDONS, AND SIMILAR REPORTS HAVE HAD MAJOR IMPACT AMONG MARSHALLESE LEADERS AT HOME IN ENGLISH, ALTHOUGH MY OWN EARLIER REBUTTAL OF FRIENDS OF MICRONESIA RELEASE ALSO HAD IMMEDIATE AND FAVORABLE IMPACT. MOST LEADERS I SPOKE TO URGE "MORE OF SAME". PARTICULARLY DAMAGING IN MAJURO IS WIDE AWARENESS AMONG EDUCATED LEADERS OF PACKARD STATEMENTS AND BELIEF HE HAS INDICATED MICRONESIA MAY BE TURNED INTO AN ARSENAL WITH REVERSIONS

OF OKINAWA. ALSO, AMONG MOST LEADERS I SPOKE TO, THERE IS CONSIDERABLE

UNHAPPINESS OVER OUR CONTINUING REQUIREMENT FOR ENIMETOK, AND SOME SUSPICION OF OUR INTENTIONS WITH RESPECT ANY FUTURE TEMPORARY EMER.

FURTHER, THERE IS NO DOUBT WHATSOEVER THAT WE NOW SHOULD RELEASE AND DISTRIBUTE AS WIDELY AS POSSIBLE HANA TRANSCRIPTS WITH COVERING SUMMARY. UNIVERSALLY THERE IS ANNOYANCE OVER SECRECY HANA TALKS, AND RESENTMENT. "PEOPLE ARE BEING KEPT IN THE DARK." ALMOST EVERYONE I SPOKE TO ASKED "WHEN WILL WE BE TOLD WHAT HAPPENED AT HANA?" THE CARDS ARE STACKED AGAINST US ON THIS ONE. ASSUMING INDEPENDENCE AS BEING ONE OF OPTIONS IN SUCH A SHOWDOWN, WE CERTAINLY WOULD RETAIN THE MARIANAS AND YAP, AND POSSIBLY PONAPE. BUT ALMOST EQUALLY CERTAINLY WE WOULD LOSE PALAU. TRUK AND PROBABLY THE MARSHALLS. THIS, OF COURSE, ASSUMES HE WOULD BE PUSHING FOR POSITION I (ONE).
