COMMITTEE ON FUTURE STATUS "HOSTING" THE MEETING. CLEARLY THE MAJOR PROGRESS MADE AT HANA ON MOST ISSUES GIVES EVERY HOPE THAT THE REMAINING ISSUES CAN AND WILL BE RESOLVED. HOW MANY FURTHER ROUNDS OF TALKS THERE WILL BE IS NOT YET CLEAR. BUT IT IS CERTAIN THAT THE CONTINUING NEGOTIATIONS FOR ASSOCIATION BETWEEN MICRONESIA AND THE UNITED STATES WILL BE A LENGTHY AND COMPLEX PROCESS GIVEN THE NEW GROUND THAT MUST BE BROKEN ON BOTH SIDES.
