Thank you for your letter of November 16 forwarding a letter from Mr. Roger W. Gale, regarding the Trust Territory of the Pacific Islands (Micronesia).

The future political status of Micronesia was the subject of discussions recently concluded in Hawaii between representatives of the Congress of Micronesia, the Territory's legislative body, and the U.S. Executive Branch. While the Department of State participated in these discussions, the U.S. Delegation was headed by Ambassador Franklin H. Williams, the President's personal representative in the future political status discussions. I have, therefore, referred your letter to Ambassador Williams for reply, and you may expect to hear from him very soon. He may be reached on 343-9143.
