1. HAVE JUST COMPLETED THREE WEEK TOUR ALL TTP! DISTRICTS ACCOMPANYING

AMBASSADOR HUMMEL (WHO DEPARTED TTPI DECEMBER 18). FOLLOWING REPORT SUMMARIZES IMPRESSIONS ON CURRENT ATTITUDES TOWARD STATUS QUESTION IN EACH OF DISTRICTS OTHER THAN MARIANAS (AMBASSADOR HUMMEL HAS

2. GENERAL. FOLLOWING ARE BASIC IMPRESSIONS WHICH APPLY IN VARYING DEGREE TO ALL DISTRICTS OTHER THAN MARIANAS. THESE IMPRESSIONS FLOW FROM MEETINGS WITH DISTRICT LEGISLATORS, MAGISTRATES, TRADITIONAL LEADERS, EXECUTIVE BRANCH OFFICERS, AND OTHER KEY MICRONESIANS IN ALL DISTRICTS.

A. GENERALLY SPEAKING KNOWLEDGE OF WHAN TRANSPIRED AT HANA

CONFINED TO FEW KEY LEADERS AND SOPHISTICATED MICRONESIANS IN DISTRICT CENTERS. AWARENESS OF HANA AND SUBSTANCE THEREOF TO ALL PRACTICAL PURPOSES NON-EXISTENT OUTSIDE DISTRICT CENTERS. THOUGH IN MOST INSTANCES KEY DISTRICT LEADERS AWARE IN VAGUE MANNER OF WHAT TRANSPIRED AT HANA, THEY ARE CONFUSED ABOUT DETAIL, AND FOR MOST PART HAVE NOT BEEN THOROUGHLY BRIEFED BY MEMBERS STATUS COMMITTEE. SAME APPLIES TO MOST MEMBERS CONGRESS WHO WERE NOT PRESENT AT HANA. ONLY IN YAP AND PALAU DOES THERE APPEAR TO HAVE BEEN CONCERTED EFFORT BY STATUS COMMITTEE MEMBERS TO BRIEF THEIR RESPECTIVE DISTRICT LEADERS

HIN TRUK, THERE APPEARS HAVE BEEN CONSCIOUS EFFORT BY AMARAICH AND NAKAYAMA TO AVOID BRIEFING DISTRICT LEADERS.) GENERAL IGNORANCE OF HANA TALKS EXISTS DESPITE CONCEPTED EFFORT BY DISTADS IN EACH DISTRICT TO DISSEMINATE INFORMATION BY RADIO. (IN ALL DISTRICTS

POLAD AND AMBASSADOR WILLIAMS' VARIOUS STATEMENTS BROADCAST IN BOTH '
ENGLISH AND LOCAL LANGUAGES. IN SOME INSTANCES THREE TIMES DAILY FOR
UP TO TWO WEEKS.)

B. AMONG THOSE DISTRICT LEADERS GENERALLY AWARE OF PROGRESS AT HANA, THERE IS NOTICEABLY HEIGHTENED CONCERN FOR THE FUTURE. IN PAST STATUS QUESTION OFTEN HAS BEEN SEEN AS SOMEWHAT ABSTRACT ISSUE OF NO IMMEDIATE CONCERN. AWARENESS THAT SELF-GOVERNMENT NOW MAY BE JUST AROUND THE CORNER IS BRINGING ABOUT INTENSIFICATION NERVOUSNESS RE UNCERTAINTIES OVER FUTURE U.S. ASSISTANCE, ABILITY OF MICRONESIANS TO GOVERN THEMSELVES, FRAGILITY MICRONESIAN UNITY, ETC. SUCH FEARS HAVE ALWAYS EXISTED BUT ARE BEING ARTICULATED IN GREATER VOLUME THAN IN PAST. SIGNIFICANTLY, MANY OF THOSE (PARTICULARLY IN PALAU) WHO HAVE

IN PAST BEEN NOSIEST IN DEMANDING SELF-GOVERNMENT (OR EVENINDEPENDENCE

ARE IN FOREFPONT OF THOSE VOCALIZING CONCERNS ABOUT EARLY STATUS SETTLEMENT. MANY LEADERS WHO HAVE IN PAST FAVORED INDEPENDENCE ARE NOW BACKTRACKING (ESPECIALLY IN TRUK AND PALAU).

C. IN THOSE CIRCLES WHERE U.S. LAND REQUIREMENTS UNDERSTOOD.
THERE APPEARS BE LITTLE VOCAL OPPOSITION THERETO, THOUGH MOST LEADERS APPEAR TO BE SITTING ON FENCE AND AWAITING FURTHER DETAILS ... I LE. A "WAIT AND SEF" ATTITUDE PENDING PRECISE DETAILS ON EXACT LOCATION.

D. TERMINATION ISSUE CAME UP IN VARIOUS DISCUSSIONS ONLY INFREQUENTLY. WHEN IT DID, MOST LEADERS SUPPORTED CONGRESSIONAL MANDATE FOR UNILATERAL TERMINATION.

F. WITH ONE OR TWO INSIGNIFICANT EXCEPTIONS, THOSE DISTRICT LEADERS

WHO ARTICULATED THEIR OWN VIEWS ON STATUS QUESTION SUPPORTED FREE ASSOCIATION CONCEPT. VIRTUALLY NO SUPPORT FOR COMMONWEALTH CONCEPT DUTSIDE OF MARIANAS.

F. DESPITE EXPRESSIONS OF CONCERN AMONG DISTRICT LEADERS, IN MOST INSTANCES SAME PERSONS INDICATED THEY ARE RELYING ON CONGRESS OF MICPONESIA'S JUDGMENT AND WILL FOLLOW CONGRESSIONAL LEAD. THIS WAS PARTICULARLY TRUE WITH RESPECT MEMBERS OF DISTRICT LEGISLATURES, AND SOMEWHAT LESS SO AMONG MAGISTRATES. AT SAME TIME MANY DISTRICT LEGISLATORS AND MEMBERS EXECUTIVE BRANCH EXPRESSED BITTERNESS OVER THEIR EXCLUSION FROM NEGOTIATIONS.

3. YAP DISTRICT. BOTH ELECTED AND TRADITIONAL LEADERS DEEPLY CONCERNED

OVER POSSIBLE CONSEQUENCES EARLY STATUS SETTLEMENT. IN GENERAL THEY BELIEVE MICRONESIA INADEQUATELY PREPARED IN TERMS BOTH ECONOMIC DEVELOPMENT AND AVAILABLE TRAINED MANPOWER. AT SAME TIME, THESE LEADERS MADE CLEAR THEY WILL FOLLOW LEAD OF THEIR CONGRESSIONAL

REPRESENTATIVES, PARTICULARLY JOHN MANGEFEL. SENATOR TUN MAY BECOME
SOMETHING OF A PROBLEM FOR US. ACCORDING TO VARIOUS SOURCES IN YAP,
HE IS IGNORING LOCAL SENTIMENT AND CONCERNS ON STATUS AND CAN JUMP
ANY WAY, INCLUDING TOWARD INDEPENDENCE, DURING CONGRESSIONAL
CONSIDERATION STATUS QUESTION. DESPITE MAJOR EFFORT BY DISTAD TO
DISSEMINATE INFORMATION ON HANA TALKS BY RADIO. GENERAL AWARENESS
OF WHAT HAPPENED AT HANA, EXCEPT AMONG FEW KEY LEADERS, NEAR ZERO.
THIS IS ACCOMPANIED BY ALMOST TOTAL APATHY EXCEPT AMONG VERY FEW KEY
LEADERS.

4. PALAU DISTRICT. DISTRICT LEADEPS MODEPATELY WELL INFORMED ON SUBSTANCE HANA TALKS AND CLEARLY PLEASED WITH RESULTS, ESPECIALLY WITH RESPECT NEW U.S. POSITION.ON LAND. HOWEVER, HIGH LEVEL SUSPICION DUR MOTIVES AND ULTIMATE INTENTIOUS REMAIN WITH LEADERSHIP TAKING "WAIT AND SEF" ATTITUDE ON LAND REQUIREMENTS. SUBMARINE BASE ISSUE

SEEMS TO HAVE DIED. SIGNIFICANTLY, THERE WAS NO ARTICULATED OPPOSITION

TO LAND REQUIREMENTS AS PRESENTLY UNDERSTOOD BY LEADERS. OF MAJOR SIGNIFICANCE WAS CHANGE OF ATTITUDE OF LEADERS AS COMPARED TO PRE-HANA PERIOD. LEADERS WHO IN PAST HAVE BEEN AGGRESSIVELY ANTI-AMERICAN WERE ALL SMILES. SOME ADMITTED THAT THEY HAD NEVER PELIEVED U.S. WOULD GIVE UP EMINENT DOMAIN. AND THAT THEIR PAST POSITIONS IN FAVOR

DISPLAYED PLEASURE WITH OUTCOME HANA TALKS, AND OPENLY AGREED ASSOCIA-

WITH U.S. ESSENTIAL AND MUST BE BASED ON COMPROMISES BY BOTH SIDES.
NEVERTHELESS, THERE ALSO REMAINS CONSIDERABLE SENTIMENT FOR SOME FORM
OF SEPARATE STATUS FOR PALAU, EVEN IF IN ASSOCIATION WITH U.S..
OF PARTICULAR IMPORTANCE AND INTEREST WAS OPEN AND FREQUENTLY
ARTICULATED FEAR THAT TERMINATION OF TRUSTEESHIP AND RETURN OF PUBLIC

LANDS TO PALAU DISTRICT WILL RESULT IN VIOLENCE IN PALAU AS CLAN FACTIONS FIGHT OVER SPOILS. ALMOST ALL LEADERS WHO SPOKE ON SUBJECT EXTREMELY PESSIMISTIC AROUT FUTURE OF MICRONESIAN "UNITY".

5. DURING VARIOUS MEETINGS IN PALAU CHIEF REKLAI REPEATEDLY AFFIRMED HIS SUPPORT OF ESTABLISHMENT MILITARY BASES IN HIS "KINGDOM" ON BABFLDAOB ISLAND. HOWEVER, THIS IS OF NO PARTICULAR HELP TO US FOR VARIETY OF REASONS. (A) NONE OF LANDS PRESENTLY CONTEMPLATED FOR MILITARY USE ARE WITHIN HIS TRADITIONAL JURISDICTION. (B) REKLAI APPEARS HAVE LITTLE SUPPORT EVEN AMONG HIS OWN PEOPLE. E.G. HE WAS RECENTLY DEFEATED IN MAGISTRATE ELECTION IN HIS HOME VILLAGE, AND HIS POLITICAL OPONENTS PICKED UP MOST SEATS IN HIS "KINGDOM" IN RECENT DISTRICT LEGISLATURE ELECTIONS.

THIS CAN BE ATTRIBUTED IN LARGE MEASURE TO SENATOR TMETUCHL'S
BRIEFINGS OF DISTRICT LEADERSHIP, AND TO FAIRLY EFFECTIVE DISSEMINATION

OF INFORMATION ON HANA BY DISTAD PUBLIC AFFAIRS STAFF. THESE ATTITUDES

COULD REVERSE WHEN EXTENT AND NATURE OUR OPTIONS IN PALAU FULLY UNDERSTOOD.

7. TRUK DISTRICT. SENATORS NAKAYAMA AND AMARAICH SEEM TO HAVE DONE LITTLE IN WAY OF BRIEFING DISTRICT LEADERS ON HANA TALKS AND LATTER

ONLY VAGUELY AWARE OF WHAT HAPPENED AT HANA. ON LAND, THERE SEEMED

TO BE AWARENESS NO REQUIREMENTS FOR TRUK, BUT SUSPICION THAT WE ARE
"HOLDING BACK." STRAINS APPEARING IN INDEPENDANCE COALITION, WITH

VARIOUS TRUKESE MEMBERS (ESPECIALLY NAKAYAMA) PRIVATELY DISOWNING
WILLIANDERS! RECENT AND FREQUENT CALLS FOR UNQUALIFIED INDEPENDENCE.

NAKAYAMA APPEARS TO BE BACKTRACKING AND IN PRIVATE CONVERSATION WITH AMBASSADOR HUMMEL AND SELF INDICATED THAT HE NOW FAVORS WHAT WOULD AMOUNT TO FREE ASSOCIATION AT ITS OUTER LIMITS. EVEN CLAIMS HE CAN GO

ALONG WITH FULL U.S. RESPONSIBILITY FOR FOREIGN AFFAIRS, PROVIDING THERE ARE ADEQUATE CONSULTATION ARRANGEMENTS. HIS MAJOR DIFFERENCE FROM OUR APPROACH TO ASSOCIATION IS THAT MICRONESIA WOULD, ON TERMINA-TION

TRUSTEESHIP, BECOME FULLY INDEPENDENT FOR BRIEF PERIOD, AND THEN ENTER INTO PRE-NEGOTIATED COMPACT FOR ASSOCIATION AS FULLY SOVEREIGN AND EQUAL PARTY. SAME APPLIES TO LAND ARRANGEMENTS. PRESUMEABLY (IN HIS VIEW) MICRONESIA WOULD REMAIN SOVEREIGN PARTY IN ASSOCIATION. ACCORDING VARIOUS OTHER SOURCES IN TRUK, NAKAYIAMA'S NEW VIEWS PROPARLY REPRESENT THOSE OF OTHER MEMBERS TRUKESE CONGRESSIONAL DELEGATION OTHER THAN WILLANDER. WHILE OPPOSITION TO FULL INDEPENDENCE

WIDESPREAD IN TRUK, CONGRESSIONAL DELEGATION PROBABLY CAN DEPEND ON DISTRICT LEADERSHIP SUPPORT FOR ANYTHING SHORT OF UNQUALIFIED

8. POMAPE DISTRICT. ONLY FEW KEY DISTRICT LEADERS INFORMED ON HANA

AND THEN IN ONLY GENERAL WAY. APATHY WIDESPREAD. REP. OLTER PAUL AND SENATOR BAILEY OLTER HAVE BOTH TOLD VARIOUS DISTRICT LEADERS THAT THEY ARE HAPPY WITH PROGRESS MADE AT HANA AND OPTIMISTIC RE PROSPECTS FOR EARLY STATUS SETTLEMENT.

9. MARSHALL ISLANDS DISTRICT. AGAIN KNOWLEDGE OF WHAT WENT ON AT HANA SEEMS TO BE CONFINED TO FEW KEY DISTRICT LEADERS WITH MOST OTHERS

TOTALLY IN THE DARK. NO OPPOSITION TO OUR LAND REQUIREMENTS IN THAT DISTRICT WERE ARTICULATED DURING VISIT. THOUGH MARSHALLESE WITH WHOM WE MET DURING VISIT DISPLAYED MORE THAN NORMAL DEGREE OF RETICENCE, THERE SEEMED TO BE GENERAL SATISFACTION WITH HANA PROGRESS AND TRENDS.
