2. JANUARY 19 HOUSE ADOPTED WITH AMENDMENTS AND RETURNED TO SENATE S.J.R. 30 WHICH CALLS FOR A SPECIAL SESSION OF CONGRESS OF MICRONESIA IN PONAPE LATER THIS YEAR. PRIMARY PURPOSE OF SESSION

PAGE TWO RUHGSAA4809 UNCLAS WOULD BE TO CONSIDER RESULTS NEXT ROUND OF STATUS TALKS. AND ANY UNFINISHED BUSINESS FROM CURRENT CONGRESSIONAL SESSION.
