SECURE ANY AND ALL MEDICAL ASSISTANCE AND AID FOR THEM FROM WHATEVER SOURCES POSSIBLE, AND SHALL ATTEMPT OBTAIN COMPENSATION FOR PEOPLE FOR INJURIES WHICH THEY SUFFERED DUE TO EXPOSURE TO IRRADIATION. SPECIAL COMMITTEE SHALL HAVE POWER TO CONDUCT HEARINGS AND INVESTIGATIONS, ISSUE SUBPOENAS REQUIRING ATTENDANCE OF WITNESSES AND PRODUCTION OF BOOKS, DOCUMENTS, AND OTHER EVIDENCE AND BRING SUITS IN ANY COURT OF TTPITO ENFORCE SUCH POWERS." PROVISION MADE IN BILL TO SUBMIT INTERIM REPORT BEFORE MAY 25, 1972 AND A FINAL REPORT TO NEXT REGULAR SESSION OF CONGRESS IN EARLY 1973.
