SUBJECT: TPI; FUTURE POLITICAL STATUS TALKS
1. SINCE HOTEL SPACE IN PALAU AND RESERVATIONS ON GUAM-PALAU FLIGHT CAN BE TIGHT AT TIMES, GRATEFUL IF YOU COULD PROVIDE FOLLOWING INFORMATION FOR PLANNING PURPOSES AS SOON AS POSSIBLE IN CONNECTION NEXT ROUND STATUS TALKS.

(A) CONFIRMATION TIME FRAME PROPOSED FOR TALKS (APPROXIMATELY TEN TO FOURTEEN DAYS COMMENCING APRIL 2) SATISFACTORY. AIR SCHEDULES ARE SUCH THAT DELEGATION WOULD HAVE TO FLY FROM GUAM TO PALAU APRIL 1 OR EARLIER. SUSPECT STATUS COMMITTEE DID NOT REALIZE APRIL 2 EASTER SUNDAY WHEN THAT DATE PROPOSED. CONSEQUENTLY TALKS MAY ACTUALLY COMMENCE APRIL 3. I WOULD ALSO PROPOSE DELEGATION LAYOVER ONE OR TWO DAYS IN GUAM WHILE EN ROUTE PALAU FOR REST PURPOSES AND FOR FINAL

REGARDING ROOM REQUIREMENTS, SUGGEST FOLLOWING. TWO ROOM SUITE FOR AMBASSADOR WILLIAMS. SINGLE ROOM FOR AMBASSADOR HUMMEL. DOUBLES FOR ALL OTHERS. ALSO TWO ROOM SUITE
