2. HE BELIEVES BEST TIME FOR U.S. DELEGATION ARRIVE PALAU IS APRIL ONE. STATUS COMMITTEE WILL HAVE ARRIVED SEVERAL DAYS EARLIER FOR ITS OWN MEETINGS. SENATOR SALII ANTICIPATES FIRST MEETING ON APRIL TWO WILL BE VERY BRIEF WITH RECESS UNTIL MONDAY APRIL THREE. I PONTED OUT THAT ONE MBER U.S. DELEGATION MAY ARRIVE IN PALAU ONE OR TWO DAYS AHEAD OF U.S. DELEGATION TO SET UP NECESSARY OFFICE AND OTHER ARRANGEM ENTS. SENATOR SALLI SAID THAT IS FINE AND SUGGESTED WHOMEVER THAT MAYBE SHOULD WORK WITH CARL HEINE.

CONCERNING CONFERENCE COSTS, SENATOR SALII CONFIRMED THAT HIS COMMITTEE WILL BE OPERATING UNDER BUDGETARY RESTRAINTS, BUT PLANS ON PIEKING UP TAB FOR U.S. DELEGATION HOTEL ROOMS AND MEALS FOR AT LEAST THE FIRST WEEK. ONLY OTHER COSTS U.S. DELEGATION WILL HAVE ARE TRANSPORATION TO AND FROM PALAU, ANY RENTAL CARS (MINIMUM FOUR REQUIRED FOR DELEGATION), AND ANY PERSONAL EXPENSES INCLUDING BARBILLS.

4. STATUS COMMITTEE WILL PROVIDE CONFERENCE STEND. SHE IS SENATE JOURNAL CLERK, MRS. NIEMAN CRALEY. JR.

5. EARLIER MESSAGE INDICATED SENATOR SALII PLANS RETURN SAN FRANCISCO IN EARLY MARCH. HE CONFIRMED THAT INFORMATION AND SAID THAT HE WOULD BE ARRIVING SAN FRANCISCO ABOUT MARCH 2 AND WILL BE IN U.S. UNTIL ABOUT MARCH 25. HOPES SEE AMBASSADOR WILLIAMS DURING THAT PERIOD. THIS COULD BE IN WASHINGTON RATHER THAN SAN FRANCISCO AS HE IS TENTATIVELY PLANNING ON VISIT TO WASHINGTON. HE SUGGESTS AMBASSADOR WILLIAMS CONTACT HIM THROUGH MRS. SALII IN SAN FRANCISCO IN EARLY MARCH TO WORK OUT TIME AND PLACE FOR MEETING.
