AND CONSTITUTIONAL PRINCIPLES AND INSTITUTIONS, AND ON ANTICIPATION CLOSE ASSOCIATION WILL STIMULATE ECONOMIC, SOCIAL,

AND POLITICAL ADVANCEMENT MARIANAS. IT ALSO ARGUES CASE FOR BEING UNDER U.S. SECURITY UMBRELLA, AND NEED TO CONTRIBUTE IN POSTIIVE MANNER

TO U.S. SECURITY REQUIREMENTS IN PACIFIC AREA. FOR THESE REASONS, REPORT STATES, MARIANAS DELEGATION CAN NO LONGER ASSOCIATE ITSELF WITH ACTIONS OF STATUS COMMITTEE (PLEASE NOTE THIS STATEMENT OVERTAKEN BY DECISIONS REPORTED REFTEL). REPORT THEN CONCLUDES WITH FOLLOWING REQUESTS AND COMMENTS.

A) REQUEST FOR ENACTMENT LEGISLATION AUTHORIZING ESTABLISHMENT SEPARATE MARIANAS DISTRICT FUTURE STATUS COMMISSION EMPOWERED CONDUCT SEPARATE NEGOTIATIONS WITH U.S..

B) REQUEST FOR CONTINUING MEMBERSHIP OF MARIANAS REPS ON CONGRESSIONAL JOINT STATUS COMMITTEE TO PARTICIPATE ONLY IN MATTERS AFFECTING MARIANAS, AND TO ACT AS LIAISON BETWEEN JOINT COMMITTEE AND MARIANAS STATUS COMMISSION.

C) PLEDGE BY MARIANAS DELEGATION TO PROVIDE "FULL, COMPLETE, AND UNEQUIVOCAL SUPPORT" TO CONGRESS AND JOINT COMMITTEE "TOWARD WHATEVER FUTURE POLITICAL STATUS THEY CHOOSE TO SEEK" AND REQUEST FOR RECIPROCAL SUPPORT FOR MARIANAS.

D) REQUEST THAT CONGRESS AGREE SEPARATE STATUS SOLUTIONS FOR MARIANAS AND FOR OTHER DISTRICTS SHALL NOT BE BINDING ON EACH OTHER.
