PALAU, FEB. 25 (MNS) -- THE CONGRESS OF MICRONESIA'S HOUSE OF REPRESENTATIVES DEFERRED ACTION FRIDAY (FEB. 25) ON SENATE JOINT RESOLUTION 91, THE RESOLUTION WHICH WOULD GIVE THE JOINT COMMITTEE ON FUTURE STATUS GREATER FLEXIBILITY IN ITS NEGO-TIATIONS WITH THE UNITED STATES ON MICRONESIA'S FUTURE.

THE RESOLUTION HAS ALREADY BEEN PASSED BY THE SENATE. IT IS BEING WATCHED CLOSELY BY MANY OBSERVERS AS A KEY TO WHETHER THE NEXT ROUND OF STATUS TALKS, SCHEDULED FOR PALAU BEGINNING APRIL 2, WILL BE FRUITFUL. A SPECIAL HOUSE COMMITTE, CHAIRED BY REPRESENTATIVE EKPAP SILK (MARSHALLS), CONSIDERED THE RESOLUTION AND STRONGLY RECOMMENDED ITS PASSAGE. THE COMMITTEE NOTED, AS DID ITS COUNTERPART COMMITTEE IN THE SENATE, THAT THE RESOLUTION IS ESSENTIAL AT THIS STAGE IN THE STATUS NEGOTIATIONS.

ACTION ON THE MEASURE WAS DEFERRED, HOWEVER, AFTER REPLACES OF THE POLYCARP BASILIUS (PALAU) STATED THAT IN VIEW OF THE IMPORTANCE OF THE MEASURE THE CONGRESSMEN SHOULD BE GIVEN MORE TIME TO STUDY IT. REPRESENTATIVE OLITER PAUL! (PONAPE) AGREED, AND A MOTION TO DEFER ACTION WAS APPROVED. IT IS LIKELY THAT THE RESOLUTION WILL AGAIN BE ON THE CALENDAR FOR SATURDAY'S HOUSE SESSION.

IN OTHER ACTION FRIDAY, THE HOUSE SENT THREE BILLS ON TO HIGH COMMISSIONER JOHNSTON FOR HIS REVIEW AND ACTION. ONE OF THE MEASURES WAS A NATURALIZATION BILL THAT WOULD MAKE CECILIA TATUWO YANGILMAU ELIGIBLE TO BECOME A CITIZEN OF THE TRUST TERRITORY.

MENTS IN MICRONESIA TO LEVY STIFFER PENALTIES FOR PERSONS WHO DISOBEY MUNICIPAL ORDINANCES THAN ARE PRESENTLY ALLOWED. FOUR OTHER BILLS WERE PASSED ON SECOND READING BY THE MEMBERS OF THE HOUSE AND WILL BE SENT TO THE SENATE FOR FURTHER ACTION. THESE BILLS INCLUDED A MEASURE RELATING TO FINANCIAL RESPONSIBILITY OF MOTOR VEHICLE OPERATORS: A MEASURE RELATING TO CONFLICT OF INTEREST IN EMPLOYMENT: A BILL THAT WOULD RESTRICT THE TAKING OF SAND, ROCK AND CORAL FROM PUBLIC BEACHES AND REEFS: AND A BILL ADDING A NEW CHAPTER TO THE TRUST TERRITORY CODE RELATED TO THE ILLEGAL EXPENDITURE OF PUBLIC FUNDS.

SEVERAL OTHER BILLS PASSED FIRST READING IN THE HOUSE FRIDAY, AND ANOTHER LARGE NUMBER OF COMMITTEE REPORTS WAS ADOPTED. ONE BILL WHICH FAILED TO GET ACTION, HOWEVER, FOR THE SECOND DAY IN A ROW, WAS A MEASURE THAT WOULD REPEAL THE TT CODE IN ITS. ENTIRETY AND REPLACE IT WITH THE TEN COMMANDMENTS. THE BILL

WAS INTRODUCED SEVERAL DAYS AGO BY REPRESENTATIVE JOHN MANGEFEL (YAP), AND WAS ASSIGNED TO SIX DIFFERENT COMMIT-TEES, A MOVE WHICH MANY THOUGHT WOULD EFFECTIVELY KILL THE MEASURE. NOT SO, HOWEVER. IT HAS EMERGED ONTO THE FLOOR. WITH THE ENDORSEMENT OF THE COMMITTEES, AND NOW THE MEMBERS ARE FACED WITH THE SOMEWHAT UNPLEASANT DECISION OF EITHER VOTING AGAINST THE TEN COMMANDMENTS OR VOTING FOR AN OBVIOUSLY IMPRACTICAL BILL. IN THE WORDS OF ONE OBSERVER OF FRIDAY'S SESSION, ACTION ON THE BILL "MAY BE DEFERRED INDEFINITELY THIS SESSION."

ON THE RESOLUTION CALENDAR, THE HOUSE ADOPTED A MEASURE CONFERRING AN HONORARY MICRONESIAN CITIZENSHIP UPON FATHER HUGH COSTIGAE N OF THE PONAPE AGRICULTURE AND TRADE SCHOOL! (PATS) AND CONGRATUATING HIM ON HIS 25TH ANNIVERSARY OF SERVICE IN MICRONESIA.

THE SENATE FRIDAY PASSED AND SENT TO THE HIGH COMMISSIONER A BILL APPROPRIATING SOME \$800,000 FOR THE CONSTRUCTION OF ROADS IN THE VARIOUS DISTRICTS. IT WAS THE DNLY BILL TO GO TO THE HICOM FROM THE SENATE, AS THE MEMBERS SPEND MOST OF THE SESSION DEALING WITH A LONG LIST OF RESOLUTIONS.

BEFORE MOVING TO THE RESOLUTIONS, HOWEVER, THEY DID PASS FOUR OTHER BILLS ON SECOND READING. THREE ARE SENATE BILLS, ONE APPROPRIATING FUNDS FOR RECREATION AND YOUTH SERVICE FACILITIES IN THE DISTRICTS, ANOTHER SETTING UP A \$600,000 HOUSING LOAN FUND, AND A THIRD SETTING ASIDE FUNDS FOR CERTAIN PROJECTS IN PALAU DISTRICT. THE FOURTH WAS A HOUSE BILLD AMENDED BY THE SENATE, WHICH APPROPRIATES \$250,000 FOR SCHOLARSHIPS. ALL FOUR MEASURES NOW GO TO THE HOUSE FOR FURTHER ACTION.

ON THE RESOLUTION CALENDAR, SEVEN HOUSE JOINT RESOLUTIONS WERE ADOPTED BY THE SENATORS, THUS COMPLETING THE LEGISLATIVE PROCESS. THE MOST SIGNIFICANT OF THESE WAS A MEASURE ASKING. THE U.S.CONGRESS AND THE SECRETARY OF THE INTERIOR TO TAKE STEPS TO INSURE THAT THE CONGRESS OF MICRONESIA IS INCLUDED IN THE PROCESS OF SELECTING THE HIGH COMMISSIONER, DEPUTY HIGH COMMISSIONER AND JUSTICES OF THE HIGH COURT IN THE FUTURE. THE SENATORS VOTED BY ROLL CALL ON THIS MEASURE, ALTHOUGH RESOLUTIONS ARE NORMALLY ADOPTED ON A VOICE VOTE. THE MEASURE PASSED WITHOUT A SINGLE NEGATIVE VOTE.

THERE WAS CONSIDERABLE DEBATE IN THE SENATE OVER A JOINT RESOLUTION THAT WOULD NOMINATE A LIST OF SEVEN MICRONESIANS FOR CONSIDERATION FOR APPOINTMENT TO THE MICRONESIA CLAIMS COMMISSION. TWO MICRONESIANS WILL BE ON THE COMMISION, WHICH IS EXPECTED TO BE NAMED LATER THIS YEAR. THE CONGRESS OF MICRONESIA HAS BEEN ASKED TO SUBMIT A LIST OF SUGGESTED NOMINEES FOR THE POSITIONS.

THE MAN WHO WAS RECOMMENDED BY THE MARIANAS POLITICAL LEADERS FOR CONSIDERATION, VICENTE N. SANTOS, WAS ALSO ON THE LIST. AFTER SOME DISCUSSION AND SEVERAL PARLITAMENTARY MOVES ON THE RESOLUTION, IT WAS FINALLY VOTED TO SEND THE MEASURE BACK TO THE COMMITTEE ON WAYS AND MEANS FOR FURTHER STUDY.

NO NEW MEASURES WERE INTRODUCED AT FRIDAY'S SENATE SESSION, AND ONLY ONE MEASURE WAS OFFERED IN THE HOUSE (SEE FOLLOWING STORY). BOTH HOUSES OF THE CONGRESS OF MICRONESIA WILL MEET SATURDAY AFTERNOON AND ARE EXPECTED TO MEET AGAIN ON SUNDAY IN THEIR EFFORT TO COMPLETE THEIR WORK BY MIDNIGHT MONDAY, THE END OF THE 50TH AND FINAL DAY OF THE SESSION. (DOMNICK OFFERS RESOLUTION)

PALAU, FEB. 25, (MNS+---REPRESENTATIVE CHARLES DOMNICK OF THE MARSHALL DISTRICT DROPPED SOMETHING OF A BOMBSHELL IN THE HOUSE OF REPRESENTATIVES FRIDAY (FEB. 25) WITH THE INTRODUCTION OF A JOINT RESOLUTION THAT WOULD HAVE THE EFFECT

SUCH A RESOLUTION HAD NOT BEEN EXPECTED THIS SESSION, WITH ONLY THE MARIANAS DISTRICT ADVOCATING A SEPARATE FUTURE STATUS FROM THE REST OF MICRONESIA UP TO THIS POINT. BEFORE THE SESSION THERE HAD BEEN SOME SPECULATION THAT THE MARIANAS WOULD OFFER SOME SORT OF RESOLUTION BY WAY OF GAINING THE ENDORSEMENT OF THE CONGRESS FOR SEPARATE STATUS NEGOTIATIONS, BUT THEY HAVE APPARENTLY DECIDED THAT NOW IS NOT THE TIME FOR SUCH A MOVE.

THUS THE DOMNICK RESOLUTION CAME AS A SURPRISE. IT FOLLOWS IN THE WAKE OF TWO DAYS OF DEBATE OVER A BILL THAT WOULD HAVE DIVIDED THE INCOME FROM THE TAXES IN PUBLIC LAW 4C-3 WITH THE DISTRICTS. THE MARSHALLS DELEGATION, AND PARTICULARLY CONGRESSMAN DOMNICK, HAD ARGUED STRONGLY IN FAVOR OF THIS MEASURE, BUT IT WAS DEFEATED THURSDAY BY A SECRET BALLOT. THERE MAY BE A CONNECTION BETWEEN THAT ACTION AND THE RESOLUTION THAT DOMNICK OFFERED FRIDAY.

BALOS OUTLINED WHAT HE FEELS SHOULD BE DONE TO PREPARE MICRONESIA TO TAKE HER PLACE AMONG THE COMMUNITY OF NATIONS. HE EMPHASIZED TRAINING, BOTH TECHNICAL AND PROFESSIONAL, AND SAID THE VARIOUS DISTRICTS MUST CONCENTRATE THEIR EFFORTS ON ACHIEVING ECONOMIC SELF-RELIANCE AND CONTROL.

"SELF GOVERNMENT, INDEPENDENCE -- AND EVEN FREE ASSOCIATION -- ARE ALL MEANINGLESS WORDS AND IDEAS," HE SAID, "UNLESS WE POSSESS THE MEANS WITH WHICH TO SUSTAIN OURSELVES IN THE MODERN, MONETARY WORLD OF TODAY." BALOS ALSO STRESSED THE IMPORTANCE OF RETAINING MICRONESIA'S CULTURAL IDENTITY. "WE SHOULD NOT BE MISGUIDED INTO EXCHANGING OUR IDENTITIES AS MICRONESIANS FOR DOLLARS FROM AMERICA," HE SAID.

IN ORDER TO SOLVE SOME OF HE PROBLEMS PRESENTLY FACING MICRONESIA, BALOS CONTINUED, "WE MUST REALIZE THAT THEY ARE NOT NECESSARILY PROBLEMS INHERENT TO MICRONESIA, BUT RATHER ARE PROBLEMS WHICH HAVE DEVELOPED FROM THE PRESENCE OF THE ADMINISTERING AUTHORITY IN MICRONESIA.

"ONE OF THE BASIC PROBLEMS WHICH HOBBLES OUR DEVELOPMENT," HE ADDED, "IS THE INFLUENCE OF U.S. MILITARY INTERESTS IN THE POLICIES OF THE ADMINISTRATION OF THE TRUST TERRITORY." BALOS SAID THE PEOPLE OF THE MARSHALL ISLANDS ARE "STRONGLY AGAINST" THE PRESENCE OF THE U.S. MILITARY IN THEIR ISLANDS, CITING THE MORAL OBJECTION OF THE PEACEFUL MARSHALLESE TO SUPPORTING THE

PRESENCE OF FACILITIES THAT DEVELOP MORE EFFECIENT MEANS OF

DESTROYING LIFE. HE ALSO SAID THE MARSHALLESE ARE TIRED OF

ENCOUNTERING BARBED WIRE FENCES AND SIGN WHICH TELL THEM THEY

CANNOT USE THEIR OWN LAND BECAUSE OF ANOTHER NATION'S INTERFSTS.

BALOS CHARGED THAT THE STRATEGIC INTEREST OF THE U.S. "NOT ONLY INFLUENCE MILITARY DECISIONS, BUT PERMEATE THE VERY MARROW OF THE THE ADMINISTRATION OF OUR ISLANDS.

"DESPITE THE GREAT INFLUX OF HIGHLY QUALIFIED AND SKILLED EXPERTS AND GREAT SUMS OF AMERICAN MONEY," HE SAID, "THERE REMAINS A GREAT WEAKNESS IN THE PRESENT ADMINISTRATION OF THE TRUST TERRITORY. THIS WEAKNESS HAS A SINGLE BASE: U.S. INTERESTS... AMERICA'S INTERESTS COME FIRST, OR WHERE MICRONESIAN INTERESTS COME FIRST, IT IS ONLY TO THE ADMINISTERING AUTHORITY'S BENEFIT."

BALOS ALSO CHARGED THAT THERE IS AN "UNREALISTICALLY NEGATIVE" ATTITUDE THAT AFFECTS THE PRESENT ADMINISTRATION. "IT IS AN ATTITUDE" HE SAID, "WHERE ONE KEEPS HEARING WHY A THING CANNOT BE DONE, RATHER THAN HOW IT CAN BE DONE. I AM NOT ANTI-AMERICAN AND I AM NOT AGAINST FOREIGNERS WORKING IN OUR COUNTRY," HE CONTINUED, "BUT I AM AGAINST ANYONE WHO COMES OUT

DEVELOPING OUR HUMAN RESOURCES AND BY WORKING WITHOUT HESITATION FOR SELF-GOVERNMENT THAT OUR STAY HERE IN PALAU AND OUR

WORK HERE IN PALAU WILL BE JUSTIFIED TO OUR FELLOW MICRONESIANS..."
