"LOCAL LEADERS" OVER ABSENCE PARTICIPATION IN STATUS NEGOTIATIONS OF TRADITIONAL AND DISTRICT LEGISLATURE LEADERS AND
URGED THEIR INCLUSION. WILIANDER POSED QUESTION ON WHERE
"AREAS OF FLEXIBILITY AND COMPROMISE" MIGHT BE AND WHETHER
THERE IS ANY INTENTION ON PART OF STATUS COMMITTEE TO COMPROMISE FOUR PRINCIPLES. SILK REFERRED WILIANDER TO STATUS
COMMITTEE'S "DRAFT REPORT" AND ALSO SAID THERE "THERE IS NO
INTENTION WHATSOEVER OF COMPROMISING" FOUR PRINCIPLES.
WILLIANDER THEN REPLIED THAT IN THESE CIRCUMSTANCES HE COULD
SUPPORT RESOLUTION AND "WILL DRAW SUPPORT OF INDEPENDENCE
