STATUS SETTLEMENT PACKAGE. ALSO, UNLIKE POSITIONS TAKEN ON TERMINATION, FOREIGN AFFAIRS, ETC., THERE IS NO SPECIFIC STATEMENT TO EFFECT COALITION WILL OPPOSE ANY SETTLEMENT WHICH DOES NOT MEET ITS REQUIREMENTS ON MILITARY ACTIVITIES AND LAND. THIS MAY HAVE BEEN AN OVERSIGHT, AND FACT REMAINS THAT CONCLUDING REMARKS IN STATEMENT CONTAIN SUCH A CONDITION WITH RESPECT ALL POSITIONS IN STATEMENT.
