PALAU APRIL 14 (MNS) --- THE FOURTH ROUND OF NEGOTIATIONS ON THE FUTURE POLITICAL STATUS OF THE TRUST TERRITORY HAS ENDED IN PALAU. THE TALKS WERE CONCLUDED LATE THRUSDAY (APRIL 13) , AT THE CONTINENTAL HOTEL IN KOROR, AND THE TWO SIDES RELEASED A JOINT COMMUNIQUE EARLY FRIDAY MORNING. THE STATEMENT READS AS FOLLOWS:

"MEMBERS OF THE JOINT COMMITTEE ON FUTURE STATUS OF THE CONGRESS OF MICRONESIA AND THE PRESIDENT'S PERSONAL REPRESENTATIVE FOR MICRONESIAN STATUS NEGOTIATIONS, MET ON KOROR PALAU FROM APRIL 2 TO APRIL 13 FOR THE FOURTH ROUND OF EXCHANGING VIEWS ON THE FUTURE POLITICAL STATUS OF THE PRESENT TRUST TERRITORY OF THE PACIFIC ISLANDS.

"BOTH DELEGATIONS FOUND THE TALKS HIGHLY USEFUL FOR THEIR EXPLORATION OF THE TWO SIDES! VIEWS AS TO THE FUTURE POLITICAL RELATIONSHIP BETWEEN THE UNITED STATES AND MICRONESIA. WHEN THE PRESENT UNITED NATIONS TRUSTEESHIP IS ENDED. BEYOND THAT THE TWO SIDES REACHED BASIC AGREEMENT ON MANY CRUCIAL AND DIFFICULT ISSUES.

MITHE FIRST AREA OF AGREEMENT IS THAT THE FUTURE RELATIONSHIP BETWEEN MICRONESIA AND THE UNITED STATES WILL BE DETERMINED BY A COMPACT. THAT COMPACT WILL BE BASED ON THE SOVEREIGN RIGHT OF THE PEOPLE OF MICRONESIA TO CHOSE THEIR OWN FUTURE. THE COMPACT WILL HAVE TO BE APPROVED BY THE CONGRESS OF MICRONESIA. THE UNITED STATES CONGRESS, AND BY THE PEOPLE OF MICRONESIA. THE COMPACT WILL ESTABLISH A MUTUALLY BENEFICIAL RELATIONSHIP OF FREE ASSOCIATION BETWEEN MICRONESIA AND THE UNITED STATES AND

MICRONESIA AUTHORITY OVER THEIR INTERNAL AFFAIRS, AND AUTHORITY OVER AND RESPONSIBILITY FOR FOREIGN AFFAIRS AND DEFENSE IS TO BE VESTED IN THE GOVERNMENT OF THE UNITED STATES. IT WAS UNDERSTOOD THAT THE GOVERNMENT OF MICRONESIA AND MICRONESIAN CITIZENS WOULD BE FREE TO NEGOTIATE AND TO SIGN CONTRACTS WHICH WILL NOT INVOLVE INTER-GOVERNMENTAL OBLIGATIONS AND RESPONSIBILITIES: THAT MICRONESIAN PARTICIPATION IN APPROPRIATE REGIONAL ORGANIZATIONS WILL BE PERMITTED AND ENCOURAGED: AND THAT THERE WILL BE CONSULTATIONS BY BOTH THE UNITED STATES AND THE GOVERNMENT OF MICRONESIA IN INTERNATIONAL MATTERS DIRECTLY IN THEIR COUNTERPARTS INTEREST.

"THE PARTIES REAFFIRMED THE PRELIMINARY AGREEMENT REACHED TAT HANA, MAUL THAT THE PEOPLE OF MICRONEISA HAVE THE RIGHT TO WRITE, ADOPT, AND AMMEND THEIR OWN CONSTITUTION, AND THAT THIS CONSTITUTION WILL NOT HAVE TO BE CONSISTENT WITH THE CONSTITUTION OF THE UNITED STATES, THAT THE UNITED STATES WILL NOT HAVE THE POWER TO AMMEND IT: AND THAT THE LEGAL, FORCE OF THE

PAGE FIVE RUHGSAA4488 UNCLAS CONSTITUTION WILL DERIVE FROM THE SOVEREIGN POWER OF THE MICRONESIAN PEOPLE \* IT WAS, HOWEVER, AGREED THAT THE. CONSTITUTION OF MICPONEISAN AND ANY AMENDMENT TO ITA WOULD NOT BE IN COMPLICATION WITH COMPACT.

"THE CONSTITUTION OF MICRONESIA WILL PROVIDE FOR THE STRUCTURE OF THE FUTURE GOVERNMENT OF MICRONESIA, THE PROCEDURE FOR THE ENACTMENT OF LEGISLATION, AND THE RELATIONSHIP BETWEEN THE VARIOUS DISTRICTS AND THE FUTURE GOVERNMENT OF MICRONESIA+ THE LAWS OF THE UNITED STATES WILL APPLY TO MICRONESIA ONLY TO THE EXTENT MUTUALLY AGREED UPON BY MICRONESIA AND THE UNITED STATES ...

MIT WAS FURTHER AGREED THAT MICRONESIAN LANDS WILL BE UNDER THE CONTROL OF THE PEOPLE OF MICRONESIA AND OF ITS GOVERNMENT. IT IS ALSO AGREED THAT ANY UNITED STATES. REQUIREMENTS FOR DEFENSE WILL BE NEGOTIATED REFORE THE SIGNING OF THE COMPACT. ANY LAND REQUIREMENTS OF THE UNITED STATES. WHICH SHOULD ARISE THEREAFTER WILL RE MET ONLY IF THE GOVERNMENT OF MICRONESIA CONSENTS, AND ONLY IN ACCORDANCE WITH MICRONESIAN LAW.

PAGE SIX RUHGSAA4488 UNCLAS STATES WILL PERMANENTLY RELINQUISH THE POWER OF EMINENT DOMAIN IN MICRONESIA.

"THE PARTIES REACHED PRELIMINARY AGREEMENT ON THE PRINCIPLE OF UNILATERAL TERMINATION UNDER WHICH EITHER PARTY MAY GIVE NOTICE AFTER THE PACT HAS BEEN IN EFFECT FOR A NUMBER OF YEARS. DETAILS IN PARTICULAR THE PRECISE LENGTH OF THAT PERIOD STILL HAVE TO BE WORKED OUT.

"BOTH SIDES AGREED THAT NEW MILITARY LEASES AND OPTIONS TO LEASE WILL CONTINUE FOR THE LENGTH OF THEIR DESIGNATED TERM, AND THAT A MUTUAL SECURITY PACT WHICH WILL PROVIDE FOR CONTINUING U.S. DEFENSE INTERESTSWILL BE NEGOTIATED IN ADVANCE OF THE SIGNING OF THE COMPACT TO GO INTO EFFECT IN THE EVENT OF TERMINATION.

MAND FINALLY THE AGREEMENTS REACHED AT HANA AND PALAU ARE UNDERSTOOD BY BOTH PARTIES TO BE PRELIMINARY PENDING FINAL AGREEMENT ON THE COMACT AS A WHOLE. THERE REMAINS A NUMBER OF AREAS WHICH ARE IN NEED OF FURTHER DISCUSSION AND AGREEMENT. THEY INCLUDE THE MATTERS OF FINANCE AND TRANSITION AND SEVERAL OTHER MATTERS LEFT OVER FROM THE TALKS A HANA LAST YEAR. IT IS ANTICIPATED THAT THERE WILL BE FURTHER DISCUSSIONS ON THESE

PAGE SIX PUHGSAA4489 UNCLAS DESIRE OF THE MARIANAS FOR A STATUS DIFFERENT FROM THAT CONTEMPLATED FOR THE OTHER FIVE DISTRICTS, THE AMBASSADOR SAID THAT THE U. S. DID NOT WISH TO IMPOSE A SOLUTION ON THE MARIANAS AGAINST THE EXPRESSED WILL OF THE PEOPLE OF THAT DISTRICT. HE STATED FIRMLY THAT HE APPRECIATED THE WARMTH AND SINCERITY OF THE MARIANAS STATEMENT.

(DELEGATIONS LEAVE PALAU)

PALAU APRIL 14 (MNS) --- MOST MEMBERS OF THE U.S. AND MICRONESIAN NEGOTIATING DELEGATIONS TO THE STATUS TALKS LEFT PALAU FRIDAY (APRIL 14), AFTER NEARLY TWO WEEKS OF ENJOYING THE HOSPITALITY AND BEAUTY OF PALAU DISTRICT.

AUTHOUGH THE BULK OF THEIR TIME WAS SPENT IN THE HARD WORK OF NEGOTIATING THE FUTURE POLITICAL STATUS OF THE TRUST TERRITORY, THE MEMBERS OF THE TWO TEAMS, AND PARTICULARLY THE AMERICANS ALSO FOUND TIME TO ENJOY THE WEATHERS THE WATERS AND A PICNIC TRIP TO THE FABULOUS ROCK ISLANDS SOUTH OF KOROR. AS THEY LEFT PALAU THE VISITORS WERE WARM IN THEIR THANKS AND PRAISE FOR THE HOSPITALITY THEY HAD BEEN SHOWN . IN THEIR JOINT STATEMENT ISSUED AT THE CONCLUSION OF THE TALKS, THE TWO-DELEGATIONS ALSO OFFICIALLY THANKED THE PEOPLE OF PALAU FOR

HAYDN WILLIAMS, WHO REPRESENTS PRESIDENT NIXON AS HEAD OF THE U.S. DELEGATION ASKING IF THE UNITED STATES WOULD ENTER INTO SEPARATE TALKS LEADING TOWARD A POLITICAL UNION WITH THE U.S. FOR THE MARIANAS.

AMBASSADOR WILLIAMS; NOTING THAT THE OFFICIAL TRANSMISSION OF THE REQUEST HAD BEEN APPROVED BY THE MICRONESIAN JOINT STATUS COMMITTEE; SAID THAT THE U.S. IS NOW WILLING TO ACEDE TO THE OFT-EXPRESSED; SAID DESIRES OF THE MARIANAS FOR SEPARATE TALKS AND A SEPARATE STATUS.

IN THE STATEMENT PRESENTED BY THE TWO MARIANAS LAWMAKERS, THEY SAID THAT THE MARIANAS ADVOCATES ITS POSITION, "...FOR THE SOLE REASON THAT WE DESIRE MEMBERSHIP IN THE UNITED STATES POLITICAL FAMILY BECAUSE OF THE DEMONSTRATED ADVANTAGES OF SUCH A RELATIONSHIP. MORE THAN ANY OTHER NATION WITH WHICH WE HAVE HAD CONTACT THE UNITED STATES HAS BROUGHT TO OUR PEOPLE THE VALUES WHICH WE CHERISH AND THE ECONOMIC GOALS WHICH WE DESIRE. CONTINUED AFFILIATION WITH THE UNITED STATES OFFERS THE PROMISE OF THE PRESERVATION OF THESE VALUES AND THE

IMPLEMENTATION OF THOSE GOALS."

THE STATEMENT CONTINUED, "THE PEOPLE OF THE MARIANAS HAVE FOR TOO LONG REEN DOMINATED BY AUTOCRATIC POWERS WITH LITTLE REGARD FOR THE RIGHTS OF THEIR OWN SUBJECTS, LET ALONE OF THE PEOPLE OF THE MARIANAS...FOR THE FIRST TIME IN FOUR CENTURIES, THE PEOPLE OF THE MARIANAS NOW LIVE AS FREE MEN. POLITICAL UNION WITH THE UNITED STATES WILL INSURE THAT WE KEEP THIS FREEDOM SO LONG DENIED TO US."

IN HIS RESPONSE, AMBASSADOR WILLIAMS SAID THAT U.S.

POLICY HAD BEEN TO DEVELOP MICRONESIA TOWARD A COMMON STATUS

UPON TERMINATION OF THE TRUSTEESHIP AGREEMENT, AND THAT THIS

HAD BEEN THE AVENUE THAT THE U.S. HAD BEEN PURSUING THROUGHOUT

THE STATUS TALKS. HE STATED, HOWEVER THAT THE RECORD OF THE

PAST TEN YEARS CLEARLY INDICATES THAT THE MARIANAS HAVE LONG

ASPIRED TO A CLOSE AND PERMANENT AFFILIATION WITH THE UNITED

STATES, AND THAT THIS SENTIMENT AND BEEN ACKNOWLEDGED BY THE

JOINT STATUS COMMITTEE AT HANA, IN OCTOBER 1971 AND AGAIN BY

APPROVING THE TRANSMITTAL OF THE REQUEST FOR SEPARATE TALKS

BY THE MARIANAS DELEGATION AT THE PALAU TALKS.

HOSTING THE FOURTH ROUND OF TALKS.

WHILE MOST OF THE MEMBERS OF THE U.S. TEAM ARE HEADING HOME AMBASSADOR FRANKLIN HAYDN WILLIAMS WILL BE TOURING THE REST OF THE DISTRICTS BEFORE HE RETURNS TO THE U.S. IT IS HIS SECOND TOUR OF MICRONESIA IN LESS THAN A YEAR. A SPOKESMAN SAID THE AMBASSADOR WISHED TO RENEW SOME OF THE ACQUAINTANCES HE MADE LAST YEAR DURING HIS FIRST TRIP TO MICRONESIA. AND

ALSO HOPED TO TALK PRIVATELY WITH VARIOUS DISTRICT LEADER AND
MEMBERS OF THE CONGRESS OF MICRONESIA WHO WERE NOT PRESENT IN

THE AMBASSADOR WAS SCHEDULED TO SPEND FRIDAY NIGHT IN YAP DISTRICT, FLYING TO GUAM ON SATURDAY AND THEN ON TO SAIPAN ON SUNDAY. ON WEDNESDAY (APRIL 19) HE IS SCHEDULED TO LEAVESAIPAN FOR PONAPE AND THEN ON TO TRUK KWAJALEIN AND MAJURO. THIS WOULD BE A LOW-KEY VISIT THE SPOKESMAN SAID, AND WOULD NOT INCLUDE ANY FORMAL MEETINGS OR PRESS CONFERENCES. (BILL ACTION)

SAIPAN APRIL 14 (MNS) --- TRUST TERRITORY HIGH COMMIS-SIONER EDWARD E. JOHNSTON CONTINUED TO ACT FRIDAY (APRIL 14) ON THE BILLS PASSED BY THE CONGRESS OF MICRONESIA DURING ITS RECENT SESSION IN PALAU: MIDNIGHT FRIDAY WAS THE DEADLINE FOR ACTION ON ALL OF THE BILLS REMAINING.

IN A SPECIAL CEREMONY IN HIS OFFICE FRIDAY MORNING, THE HICOM SIGNED INTO LAW A MEASURE THAT WILL PROVIDE \$200,000 DOLLARS FROM THE GENERAL FUND OF THE CONGRESS OF MICRONESIA FOR FUNDING VARIOUS PROJECTS IN THE MARIANAS DISTRICT. REPRESENTATIVE FELIPE ATALIG RESPRESENTED THE MARIANAS CONGRESSIONAL

DELEGATION AND WITNESSED THE SIGNING. AFTERWARD, HE SAID THE

DELEGATION IN CONTINUING TO PROVIDE BETTER HEALTH AND SOCIAL SERVICES, AND CONTINUING PUBLIC IMPROVEMENT PROJECTS IN THE MARIANAS.

THE BILL WAS SIMILAR TO BILLS PASSED FOR EVERY OTHER DISTRICT WHICH WILL FUND SPECIAL PROJECTS. THE MEASURES REPRESENT A RETURN TO THE DISTRICTS OF SOME OF THE MONEY RAISED THROUGH ENACTMENT OF THE TERRITORY-WIDE INCOME AND BUSINESS TAX LAW THAT WENT INTO EFFECT LAST YEAR. THAT LAW GAVE THE CONGRESS OF MICRONESIA A GREAT DEAL OF ADDITIONAL REVENUE FOR APPROPRIATION.

IN OTHER ACTIONS TAKEN FRIDAY THE HICOM SIGNED THE FOLLOWING BILLS INTO LAW: HOUSE BILL 51WHICH RECOMES PUBLIC LAW 4C-76 AND ESTABLISHES DISTRICT PLANNING COMMISSIONS; ENABLING THE DISTRICT GOVERNMENTS TO ENACT ZONING LAWS: HOUSE BILL 127, NOW PUBLIC LAW 4C-78; WHICH ESTABLISHES A TRUST TERRITORY ENVIRONMENTAL PROTECTION GOARD: HOUSE BILL 215; NOW PUBLIC LAW 4C-79; WHICH RELATES TO THE LICENSING OF MOTOR VEHICLE OPERATORS: AND HOUSE BILLS 175 AND 176; NOW PUBLIC LAWS

PAGE FIVE RUHGSAA4490 UNCLAS 4C-73 AND 4C-74 WHICH PROVIDE FUNDS FOR THE OPERATING AND CONTINGENT EXPENSES OF THE CONGRESS OF MICRONESIA.

LATE THURSDAY AFTERNOON AND EVENING THE HICOM ALSO TOOK THE FOLLOWING ACTIONS WHICH HAVE NOT YET BEEN REPORTED BY MICRONESIAN NEWS SERVICE: HE SIGNED INTO LAW HOUSE BILL 125 (PL4C-58) . ALL OF THESE ACTIONS LEFT JUST THREE BILLS STILL AWAITING A DECISION AS OF FRDIAY AFTERNOON. THESE WERE: HOUSE BILL 122, WHICH WOULD APPROPRIATE FUNDS FOR THE OPERATION OF THE DISTRICT TAX OFFICES: HOUSE BILL 139, WHICH WOULD PROVIDE FOR THE PAYMENT OF FORFEITED ANNUAL LEAVE FOR GOVERNMENT EMPLOYEES: AND HOUSE BILL 249, WHICH WOULD APPROPRIATE \$5,000 DOLLARS AS A PAYMENT TO NEW YORK ATTORNEY HARROP FREEMAN FOR HIS SERVICES TO THE CONGRESS OF MICRONESIA. IT WAS ATTORDED THAT AT LEAST. ONE OF THESE BILLS--THE ONE DEALING WITH HARROP FREEMAN--
