PARA 12 REFTEL ANTICIPATES MICRONESIAN REQUEST FOR PARTICIPATION ON US DEL TO 1973 LOS CONFERENCE AND URGES OUR GRAGREEMENT TO THIS REQUEST ON GROUNDS US DEL ALLED & GEDLY PROMISED SUCH PARTICIPATION ON US DELEGATIONS DURING RECENT STATUS TALKS ON PALAU. US DEL GAVE NO REPEAT NO SUCH ASSURANCE AND MICRONESIANS SHOULD NOT BE MISLED OR ENCOURAGED TO BELIEVE THAT THEY HAVE RIGHT REPEAT RIGHT TO PARTICIPATE ON US DELEGATIONS.

AT APRIL SESSION OF STATUS TALKS HELD IN PALAU, US DEL PROPOSED THAT ALTHOUGH UNDER OUR CONCEPT OF NEW RELATIONSHIP USG WOULD HAVE FULL AUTHORITY OVER AND RESPONSIBILITY FOR MATTERS RELATING TO FOREIGN AFFAIRS IN MICRONESIA, WE WOULD AGREE IN MICRONESIAN INTEREST TO CONCLUDE INTERNATIONAL AGREEMENTS OF STRICTLY LOCAL CONCERN ONLY WITH MICRONESIAN CONSENT AND HOPEFULLY WITH MICRONS≹ESIAN PARTICIPATION IN THE PREPARATION FOR OR NEGOTIATION OF SUCH AGREEMENTS. THIS PROPOSAL CLEARLY LIMITED TO AGREEMENTS SUCH AS CONTEMPLATED MICRONESIA-NAURU IMMIGRATION PACT WHICH WOULD NOT AFFECT OR INVOLVE US INTERESTS.
