1. [ ] U.N. TRUSTEESHIP SECTION  
DEPARTMENT OF FOREIGN AFFAIRS, HAS REQUESTED THE  
EMBASSY TO FIND OUT WHAT THE EXPECTED COMPOSITION IS  
FOR THE U.N. TRUSTEESHIP COUNCIL MISSION TO MICRONESIA  
NEXT YEAR. [ ] THIS INFORMATION WOULD BE  
USEFUL TO HIS OFFICE IN PREPARING THE AUSTRALIAN  
SUBMISSION TO THE TRUSTEESHIP COUNCIL THIS YEAR. WE  
UNDERSTAND THIS SUBMISSION WILL TAKE PLACE IN THE NEAR  
FUTURE AND WILL FOLLOW THE U.S. PRESENTATION  
TO THE TRUSTEESHIP COUNCIL ON THE STATUS OF THE  
TRUST TERRITORY OF THE PACIFIC ISLANDS.

2. [ ] ASKED SPECIFICALLY WHETHER IT IS ANTICIPATED  
A) THAT THE COMMITTEE OF 24 WILL BE INVITED TO PARTI-  
CIPATE IN THE TTPI MISSION. IN THIS CONNECTION HE  
NOTED THAT TWO MEMBERS OF THE COMMITTEE OF 24 HAD  
PARTICIPATED IN LAST YEAR'S VISIT TO PAPUA NEW GUINEA.
