SUBJECT: TTPI - NEW POLAD'S CONSULTATIONS IN TTPI
1. REF MY MAY 18 (LOCAL TIME) TELEPHONE CONVERSATION'S WITH CHARLES SYLVESTER (10/UN), SUGGEST MY SUCCESSOR'S TRAVEL ORDERS PROVIDE FOR APPROXIMATELY THREE WORKING DAYS CONSULTATIONS ON SAIPAN, ONE WORKING DAY ON GUAM AT COMNAVMARIANAS, AND APPROXIMATELY THREE DAYS EACH IN TRUK, PONAPE, AND MAJURO. ALSO SUGGEST ONE WORKING DAY IN HONOLULU AT CINCPAC, AND ONE DAY IN SAN FRANCISCO WITH AMBASSADOR WILLIAMS. MY HOME LEAVE AND TRANSFER ORDERS SHOULD PROVIDE FOR SIMILAR CONSULTATIONS SO THAT WE CAN TRAVEL TOGETHER.

2. REGARDING ROUTING FROM SAIPAN TO SAN FRANCISCO, TA FOR BOTH SUCCESSOR AND SELF SHOULD SPECIFICALLY PROVIDE FOR FOLLOWING ROUTING: SAIPAN-GUAM-PONAPE-TRUK-MAJURO-HONOLULU-SAN FRANCISCO.

ADDITION THESE DISTRICTS NOT IMPERATIVE AND WOULD LENGTHEN TRIP BY ABOUT ONE WEEK WHEN TIME CRITICAL IN TERMS OF TIMING NEXT ROUND STATUS TALKS, AND MY ABILITY TAKE ANY LEAVE PRIOR REPORTING FOR DUTY IN DEPARTMENT AS INDICATED ON TELEPHONE I PLAN SPEND AT ABOUT TEN DAYS IN CALIFORNIA VISITING PARENTS BEFORE ARRIVAL IN WASHINGTON.

4. ALSO REQUEST THAT DEPARTMENT WORK OUT WITH AMEMBASSY MANILA AGENT CASHIER APPOINTMENT FOR MY SUCCESSORS TO BECOME EFFECTIVE DURING LATTER'S INITIAL CONSULTATIONS ON SAIPAN.
