1. IN CONVERSATION MAY 17, SENATOR SALII ASKED ME CHECK OUT
WHETHER AMBASSADOR WILLIAMS AND U.S. DELEGATION WOULD BE PREPARED
HOLD FURTHER TALKS IN WASHINGTON COMMENCING LAST WEEK OF JUNE OR
FIRST WEEK OF JULY. SALII SAID ENTIRE STATUS COMMITTEE WOULD GO TO
WASHINGTON AND WOULD BE PREPARED STAY THREE OR FOUR WEEKS IN

EFFORT REACH AGREEMENT ON REMAINING KEY ISSUES, WORK OUT DETAILED
LANGUAGE, AND HOPEFULLY COME UP WITH "FIRST ROUGH DRAFT" OF
COMPACT. FROM HIS REMARKS, HE IS FULLY AWARE ANY SUCH ROUGH
DRAFT WOULD HAVE GAPPING HOLES IN IT. BUT HE SEEMS BELIEVE IT IS
IMPORTANT HAVE SOME SORT OF AGREED LANGUAGE IN COMPACT FORM ON KEY
ISSUES TO PLACE BEFORE SPECIAL SESSION OF CONGRESS OF MICRONESIA
LATER IN SUMMER. REGARDING MECHANICS OF TALKS, HE ENVISAGES
BOTH FULL PLENARY SESSIONS, AND JOINT SUB-COMMITTEE EFFORTS DIRECTED
AT THRASHING OUT OF DETAILS.
