3) TO ASSEMBLE DATA REGARDING RIGHTS AND CLAIMS OF  
TT AND ITS INHABITANTS TO TREATMENT OR USAGE THE SAME AS,  
OR EQUAL TO, THAT RECEIVED BY OTHER TERRITORIES AND COUNTRIES
