

What were the decisions of the Election Board members and/or the Election Commissioner?

Yes, there were complaints of illegal voting and others. They were: (1) that there were people who actually marked ballots for some other voters; (2) that there were people who were campaigning within the 100 feet from the ballot box; (3) that there were people who actually told voters not to vote for so and so but to vote for so and so. The decision of the Election Board is that even if these complaints were true, as far as the members of the Election Board are concerned, there were no such events took place. The Election Board clearly made their recommendation to the Election Commissioner that none of them was aware that such practices during the election existed.

11. Did any candidate petition for a recount of the ballots? If so, what were the complaints? What action was taken on the petition(s)?

There were <sup>no</sup> petitions for recount, but there were petitions for re-election on the ground that the election was conducted illegally and most of the bonafide residents of the district were not allowed to vote because their names did not appear in the registration lists.


