DISCUSSING SUBJECT YESTERDAY NOV 8, HICOM TOLD ME THAT HE HAD ASSURED DELEGATION THAT SUBJECT WOULD BE CONSIDERED AT TT HEADQUARTERS AND AT DEPT OF INTERIOR.

3. FEW DAYS AGO SPECIAL LEGISLATIVE CONSULTANT CRALEY RECEIVED LETTER FROM COM STAFF ATTORNEY MIKE WHITE PICKING UP THIS SUBJECT, APPARENTLY FROM MNS ITEM, AND ASSERTING THAT COM IS PROPER BODY TO CONSIDER MATTER.

4. ALTHOUGH NOTING THAT KUSAIE GIVES NO INDICATION OF WANTING TO OPT OUT OF MICRONESIA, [CRALEY, IN DISCUSSING SUBJECT,] COMMENTED THAT HE SEES FRAGMENTATION IN ONE FORM OR ANOTHER AS POTENTIAL PROBLEM, EXACERBATED BY MARIANAS SEPARATION. HE SAYS HE HAS MADE THIS POINT TO INDEPENDENCE ADVOCATES, OBSERVING THAT IF MICRONESIANS SHOULD DECIDE THEY
