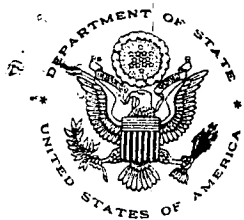

1. FOLLOWING IS TEXT OF DRAFT PRESS RELEASE WHICH SENATOR PANGELINAN INTENDS TO RELEASE PRIOR HIS DEPARTURE SAIPAN NOV 24; "SAIPAN, M.I. THE MARIANAS POLITICAL STATUS COMMISSION HELD ITS SECOND MEETING ON NOVEMBER 18, 1972, IN CONTINUATION OF ITS ACTIVITIES PURSUANT TO DISTRICT LAW 3-124. THE COMMISSION WAS CREATED BY THE MARIANA ISLANDS DISTRICT LEGISLATURE DURING ITS HISTORIC FIRST SPECIAL SESSION HELD LAST MAY OF THIS YEAR, WHICH WAS CALLED FOR THE PURPOSE OF ENTERTAINING DISCUSSION FOR THE ESTABLISHMENT OF A STATUS COMMISSION FOR THE MARIANAS WHICH WILL LEAD TO A CLOSE POLITICAL RELATIONSHIP BETWEEN PEOPLE OF THE MARIANAS AND THE UNITED STATES OF AMERICA.

PAGE TWO RUHNSAA6316 CONFIDENTIAL SECTION 1 OF THE DISTRICT LAW STATES THE INTENTION OF THE ACT BY PROVIDING THAT "THE MARIANAS ISLAND DISTRICT LEGISLATURE FINDS THAT THE PEOPLE OF THE MARIANAS ISLANDS DISTRICT DESIRE A CLOSE POLITICAL RELATIONSHIP WITH THE UNITED STATES OF AMERICA, A FUTURE POLITICAL STATUS DIFFERENT FROM THAT WHICH HAS BEEN TENTATIVELY CHOSEN BY THE PEOPLE OF THE REMAINDER OF THE DISTRICT OF THE TRUST TERRITORY OF THE PACIFIC ISLANDS, AS EXPRESSED BY THEIR

REPRESENTATIVES IN THE CONGRESS OF MICRONESIA. THE MARIANAS ISLANDS DISTRICT LEGISLATURE FURTHER NOTES THAT THE PROVISIONS OF THE CHARTER OF THE UNITED NATIONS, AND OF THE TRUSTEESHIP AGREEMENT, CALL FOR SELF-DETERMINATION AND SELF-GOVERNMENT FOR ALL PEOPLE OF THE TRUST TERRITORY. SINCE THE CONGRESS OF MICRONESIA HAS REACHED A TENTATIVE SOLUTION TO THE QUESTION OF POLITICAL STATUS NOT IN ACCORDANCE WITH THE WISHES OF A MAJORITY OF THE PEOPLE OF THE MARIANAS, THE MARIANA ISLANDS DISTRICT LEGISLATURE VIEWS IT IMPERATIVE THAT THE PEOPLE OF THE MARIANAS TAKE APPROPRIATE AND NECESSARY STEPS TOWARD THEIR OWN RESOLUTION OF THIS IMPORTANT QUESTION. TO THIS EXTENT, THE MARIANA ISLANDS DISTRICT LEGISLATURE HEREBY CREATES THE MARIANAS POLITICAL STATUS

COMMISSION, AND SETS FORTH 1ST POWERS AND DUTIES."  
THE MEMBERS OF THE COMMISSION ARE: VICENT N. SANTOS AND FELIPE A. SALA (D.L.), EDWARD DLG. PANGELINAN AND HERMAN O GUERRERO (CON. MIC), BENJAMIN T. MANGLONA AND JOANNES R. TAIMANAO (ROTA MUNICIPAL COUNCIL), VICENTE T. CAMACHO AND DANIEL T. MUNA (SAIPAN LEGISLATURE), OLYMPIO T. BORJA (N. MARIANAS), JOAQUIN T. PANGELINAN (POPULAR PARTY), FRANCISCO T. PALACIOS (TERRITORIAL PARTY), FELIX RABULIMAN (U.C.L.A.), AND JOSE C. TENORIO (BUSINESS ASSOC.).

THE STATUS COMMISSION HAS HELD AN ORGANIZATIONAL MEETING DURING THE FIRST WEEK OF SEPTEMBER OF THIS YEAR. DURING THAT MEETING SENATOR EDWARD DLG. PANGELINAN OF THE CONGRESS OF MICRONESIA AND PRESIDENT VICENTE N. SANTOS OF THE MARIANA ISLANDS DISTRICT LEGISLATURE WERE SELECTED CHAIRMAN AND VICE-CHAIRMAN RESPECTIVELY. THE ACTIVITIES AND FUNCTIONS OF THE COMMISSION ARE DELEGATED TO THREE STANDING COMMITTEES WHICH WILL UNDERTAKE MUCH OF THE PRELIMINARY STUDIES AND INVESTIGATION OF THE COMMISSION ON MATTERS PERTAINING TO AND RELATING TO THE FUTURE POLITICAL STATUS OF THE MARIANAS. THE STANDING COMMITTEES OF THE COMMISSION ARE: COMMITTEE ON MILITARY AND LAND MATTERS, CHAIR BY MR. DANIEL T. MUNA; COMMITTEE ON POLITICAL AND GOVERNMENTAL MATTERS, CHAIR BY MR.

SOCIAL MATTERS, CHAIR BY MR. JOSE C. TENORIO. A COMMITTEE ON RULES, CHAIR BY MR. JOAQUIN I. PANGELINAN, IS ALSO CREATED FOR THE PURPOSE OF ESTABLISHING RULES OF PROCEDURE FOR THE COMMISSION. DURING THE SECOND MEETING HELD LAST WEEKEND, MATTERS OF IMPORTANCE RELATIVE TO THE FORTHCOMING FORMAL NEGOTIATION ON THE FUTURE POLITICAL RELATIONSHIP BETWEEN THE PEOPLE OF THE MARIANAS, AND THE UNITED STATES WERE DISCUSSED. THE COMMISSION HAS INSTRUCTED THE CHAIRMAN SENATOR EDWARD PANGELINAN, TO TRAVEL TO MAINLAND LATE NOVEMBER TO MEET WITH THE PRESIDENT'S PERSONAL REPRESENTATIVE, AMBASSADOR F. HAYDN WILLIAMS, TO FIRM UP PRELIMINARY PLANS FOR THE HISTORICAL FORMAL MEETING BETWEEN THE MARIANAS POLITICAL STATUS COMMISSION AND THE UNITED STATES DELEGATION TO BE HELD SOMETIME IN DECEMBER IN SAIPAN. WHILE IN THE UNITED STATES CHAIRMAN PANGELINAN WILL ALSO SPEND HIS TIME INTERVIEWING PROSPECTIVE CONSULTANTS WHO WILL ASSIST THE COMMISSION IN ITS WORK LEADING TOWARD FORMAL DISCUSSION AND NEGOTIATION WITH THE UNITED STATES DELEGATION.
