YOUR LETTER WRITTEN PRIOR TO YOUR DEPARTURE FOR TOKYO RECEIVED. HAD HOPED TO HAVE FURTHER TELEPHONE CONVERSATIONS WITH YOU ON YOUR RETURN TO SAIPAN AND PRIOR TO YOUR DEPARTURE FOR KOROR. GIVEN THE DEVELOPMENTS SUBSEQUENT TO YOUR LETTER WHICH YOU MENTIONED IN YOUR CALL FROM TOKYO AND THE CONTINUING UNCERTAINTIES ON OUTCOME OF ELECTION THERE ON MEMBERSHIP OF NPSO, FURTHER DISCUSSIONS WITH YOU WILL BE NECESSARY PRIOR TO ANY DECISION ON THE NEXT PHASE OF THE NEGOTIATIONS. HAD HOPED IT WOULD BE POSSIBLE FOR YOU AND EKPAP TO COME TO SEE ME IN SAIPAN OR WASHINGTON FOLLOWING YOUR ELECTIONS FOR PLANNING TALKS AS DISCUSSED PREVIOUSLY. SINCE YOUR PRIOR COMMITMENT AND TRIP TO PALAU SEEM TO MAKE THIS IMPOSSIBLE, SUGGEST THAT I MEET WITH YOU FOR FULL EXCHANGES IN GUAN OR SAIPAN AROUND DECEMBER 11 PRIOR TO MY MARIANAS MEETING IN SAIPAN, FOR WHICH WE HAVE NOW HAD TO SET DATES IN VIEW OF TIME PRESSURES BEFORE THE HOLIDAYS. YOU MAY WISH TO INVITE EKPAP TO JOIN US FOR THIS HEADS OF DELEGATION MEETING DEPENDING ON FINAL ELECTION RESULTS FROM THE MARSHALLS. WOULD APPRECIATE YOUR CADLING OR CALLING ME AT YOUR EARLIEST CONVENIENCE. I WILL BE IN SAN FRANCISCO THROUGH DEC 3 AND IN WASHINGTON THE FOLLOWING WEEK. BEST REGARDS-HAYDN.
