SUBJ: MARIANAS STATUS NEGOTIATIONS

1. AMBASSADOR WILLIAMS, THE PRESIDENT'S PERSONAL REPRESENTATIVE FOR MICRONESIAN STATUS NEGOTIATIONS, AND SENATOR PANGELINAN, CHAIRMAN OF THE MARIANAS POLITICAL STATUS COMMISSION HAVE AGREED TO HOLD THE INITIAL SESSION OF SUBJECT NEGOTIATIONS IN SAIPAN COMMENCING ON 13 DECEMBER AND RUNNING FOR 2 DAYS. DATES WILL BE ANNOUNCED OFFICIALLY LATER (PROBABLY ON DEC 7 OR 8) AND MEANWHILE SHOULD NOT BE PUBLICLY DISCUSSED.
2. THE U.S. DELEGATION WILL INCLUDE AMBASSADOR WILLIAMS, JAMES M. WILSON, JR., (U.S. DEPUTY REPRESENTATIVE), STANLEY CARPENTER (DEPUTY ASSISTANT SECRETARY OF INTERIOR), AND CAPTAIN WILLIAM J. CROWE, JR., USN, (OMSN). ADVISERS WILL BE ADDED AS NECESSARY AND ADDRESSEES WILL BE INFORMED.
3. ACCOMODATIONS IN SAIPAN ARE BEING ARRANGED BY THE MARIANAS DELEGATION.

- 4. FOR CINCPACREP GUAM. REQUEST RESERVATIONS BE MADE FOR NIGHTS OF 10 AND 11 IN GUAM FOR AMBASSADOR AND 7. PARTY WILL BE ARRIVING 1930 LOCAL VIA TWA 745 FROM HONOLULU. ALSO REQUEST THAT AN APPOINTMENT BE MADE FOR AMBASSADOR WILLIAMS TO CALL ON GOVERNOR COMACHO ON 11 DECEMBER AND IN HIS ABSENCE LT.GOV. MOYLAN. AMBASSADOR WILLIAMS AND SENATOR SALII PLAN TO MEET ON 11 DECEMBER IN GUAM BUT TIME AND PLACE HAVE NOT BEEN SETTLED AS YET.
- 5. FOR CINCPAC. WILL INFORM CAPT. CROCKETT BY FONCON WHEN PLANS FOR TRANSITTING HAWAII ARE FIRM. AMBASSADOR WILLIAMS DESIRES TO CALL ON ADMIRAL GAYLOR THE MORNING OF 9 DEC. IF IT IS CONVENIENT.
- 6. FOR STATUS LNO. PLEASE CONFIRM THAT SENATOR PANGELINAN IS ARRANGING ACCOMODATIONS SAIPAN. LIKewise, CONSULT WITH SENATOR SALII ON TIME AND PLACE HE WILL MEET WITH AMBASSADOR WILLIAMS ON 11 DECEMBER AND COORDINATE WITH CINCPACREP TTPI IN ORDER TO AVOID CONFLICT WITH AMBASSADOR'S CALL ON GOVERNOR OR LT. GOVERNOR.
