SUBJ: MARIANAS STATUS NEGOTIATIONS

1. AMBASSADOR WILLIAMS, THE PRESIDENT'S PERSONAL REPRESENTATIVE FOR MICRONESIAN STATUS NEGOTIATIONS, AND SENATOR PAN-GELINAN, CHAIRMAN OF THE MARIANAS POLITICAL STATUS COMMISSION HAVE AGREED TO HOLD THE INITIAL SESSION OF SUBJECT NEGOTIATIONS IN SAIPAN COMMENCING ON 13 DECEMBER AND RUNNING FOR 2 DAYS. DATES WILL BE ANNOUNCED OFFICIALLY LATER (PROBABLY ON DEC 7 OR 8) AND MEANWHILE SHOULD NOT BE PUBLICLY DISCUSSED.

2. THE U.S. DELEGATION WILL INCLUDE AMBASSADOR WILLIAMS, JAMES M. WILSON, JR., (U. S. DEPUTY REPRESENTATIVE), STANLEY CARPENTER (DEPUTY ASSISTANT SECRETARY OF INTERIOR), AND CAPTAIN WILLIAM J. CROWE, JR., USN, (OMSN). ADVISERS WILL BE ADDED AS NECESSARY AND ADDRESSEES WILL BE INFORMED.
