Floor Leader Silk: Mr. Speaker, I would like the House to recognize the presence of two members of the Marshall Islands Nitijela in the gallery this morning -- Legislator Kunar Abner, and Legislator Andrew Hisaiah.

# Representative Hadley:

"Mr. Speaker, I have learned recently that the Trust Territory Administration has been committing expensive mistakes in its personnel hiring.

"A case in point, Mr. Speaker, is the hiring of one Macke Williams in the Department of Education. Mr. Williams was hired last August by the Acting Director of Education to be the Coordinator of Elementary and Secondary Education. He took the job in good faith, taking a drastic cut in his salary because he desired to come and really help the people of Micronesia. But for the six months he has been here, he is said to be doing nothing and now he is leaving the Trust Territory in complete disgust.

"Mr. Speaker, as I see it, this sort of situation is very unfair to all parties involved and ought not to be tolerated anymore. It is unfair, Mr. Speaker, for Mr. Williams because he was promised many things which have not materialized. He is now leaving with a sour memory of us. It is also unfair to the Micronesian who has been occupying the position for which Mr. Williams was hired. But more importantly, Mr. Speaker, it is unfair to the American tax payers and the people of Micronesia because now the Trust Territory is paying this expensive mistake because of a commitment made by one person. Mr. Williams came at government expenses, paid a full salary for doing nothing, and now he is leaving, again at government expense. Altogether, Mr. Speaker, the mistake will cost over \$11,000 to the Trust Territory Government.

"Mr. Speaker, something must be done to prevent a repetition of these expensive mistakes. This is another example of sheer waste. We cannot afford to waste any more. May I suggest, Mr. Speaker, that the Committee on Education look into this matter and tell us how this expensive mistake occurred in the Education Department of our Government.

"Thank you."

# SPECIAL AND CONFERENCE COMMITTEE REPORTS

Floor Leader lehsi moved for adoption of Special Committee Report No. 3 from the Joint Committee on Marine Resources, on marine resources development.

Vice-President Salii seconded.

<u>Floor Leader lehsi</u>: Mr. President, I have a prepared statement here, but, instead of reading it, I will submit it to the Clerk for insertion in the journal. This statement is in support of the report and its recommendations.

The Chair so directed the Clerk. Following is the statement:

"Mr. President and fellow members of the Senate:

"As has been said many times before, the resources of the sea are our most abundant and important resource. With the decline of copra production and income derived from copra, Micronesians living away from the district center areas probably have fewer income earning opportunities than they did five or ten years ago. What we need are industries within which Micronesians, who are not employed in the district centers, can participate in order to provide income and develop economically the outer villages, municipalities and islands. Fisheries offers the promise of providing such an industry.

"Mr. President, the Joint Committee on Marine Resources was created to study and recommend ways of developing our marine resources, especially fisheries resources. Fishery development is suffering from chronic inertia. The lack of development is largely a product of lack of encouragement and support from the Government. Mr. President, we hope that the recommendations and legislation resulting from the work of the Joint Committee on Marine Resources is capable of breaking that inertia.

"Mr. President, the Joint Committee on Marine Resources disagrees with the philosophy of the Government of bringing in large foreign companies to develop our fisheries for us. For development to be truly Micronesian, for it to utilize the resources of the sea to the greatest advantage of Micronesians, it must be developed by Micronesians. But development cannot begin on a massive multi-million dollar scale -- it must begin on a small scale. Business organizations must be established capable of handling a small scale local fishery and then once the skills necessary for such an industry are mastered, expanded into a larger scale export business.

"Mr. President, in the time permitted the committee we were unable to study the whole range of problems related to the development of both our living and mineral resources of the sea. Consequently we concentrated our efforts on contriving a means to develop a local fishery capable of fully meeting the domestic demand for fish in Micronesia. In order to develop a fishery capable of meeting the local demand for fish, Mr. President, the Joint Committee on Marine Resources, in its report which we are releasing to the Senate today, recommends that fishing cooperatives be used as the primary business organization as is done in Japan, Korea, Taiwan and the Philippines. Micronesians have a great deal of experience in the operation of cooperatives and cooperatives tend to spread the benefits of development over a larger number of people than do other forms of business institutions. Based on the findings of the committee and on our experience in the functioning of cooperatives in Micronesia, we feel that they are capable of developing a local fishery, given adequate encouragement, guidance and support from the Government. The Government must support cooperatives by providing them with funds to build reefer facilities and for loans to fisherwen, and must also closely regulate them.

"Mr. President, another recommendation of the committee is that a single port in each district be opened, subject to the approval of the district legislature, for call by all foreign fishing vessels. Foreign fishing vessels should be allowed to purchase food, fuel, water and bait fish at these ports and crew members should be permitted shore leave. In order to act as agent for the sale of provisions to foreign fishing vessels, formulate district fishing policy, channel funds to cooperatives, and regulate the activities of the fishing cooperatives, a district fishing association should be created in each district. The committee recommends that the district fishing association be composed of representatives from each of the fishing cooperatives in the district plus the district representative of the Division of Marine Resources. Profits from the sale of provisions to foreign fishing vessels should be used to defray the costs of operation of the district fishing association and the remainder distributed to the fishing cooperatives for use in a loan fund for fishermen.

"Mr. President, the committee also recommends that a permanent joint committee on marine resources be created for the purpose of dealing with problems such as devising a means to develop the offshore fishery and to serve the function of overseeing marine resource development in general.

"Mr. President, quite a number of other recommendations were made by the committee, too many to be reviewed at this time. These recommendations may be found in the chapter in the report entitled 'Recommendations' and they are also summarized in the last chapter.

"Mr. President, ten pieces of legislation, including four appropriation measures, totaling one million twenty thousand dollars, have been prepared by the committee and introduced into the House of Representatives. The committee hopes that the members of the Senate will carefully study our report and the legislation and act favorably upon them.

"Thank you, Mr. President."
