SUBJECT: CONVERSATIONS WITH SENATOR PANGELINAN

1. IN ADDITION TO CONSIDERATIONS WORRYING PANGELINAN RAISED REFTEL ON SEPARATION AND INTERIM ARRANGEMENTS THERE IS OBVIOUS CONSIDERATION OF MARIANAS DESIRE TO KEEP ITS CITIZENS ON TTPI AND COM PAYROLLS. YOU MAY ALSO FIND INTERESTING FOLLOWING REMARKS MADE LAST WEEK TO WILLIAMS AND WILSON BY PAUL WARKE.
2. WARKE DESCRIBED IN CONFIDENCE CERTAIN ASPECTS OF SESSIONS OF JCFS A MONTH AGO AT WHICH HE HAD BEEN PRESENT. SPECIFIC QUESTION RAISED WAS CONTINUED PRESENCE OF MARIANAS REPRESENTATIVES ON JCFS AND INCLUSION OF MARIANAS WITH OTHER DISTRICTS IN PROPOSED CONSTITUTIONAL CONVENTION BILL. HE INDICATED PANGELINAN AND TO A LESSER EXTENT GUERREIRO HAD JUSTIFIED THEIR CONTINUED ACTIVITIES IN THESE MICRONESIA-WIDE DISCUSSIONS ON GROUND THAT IF MARIANAS DISTRICT IN FINAL PLEBESCITE REJECTED AGREEMENT WITH

U.S. ON PERMANENT ASSOCIATION THEY COULD THEN BE OFFERED AS ALTERNATIVE WHATEVER HAD BEEN WORKED OUT FOR MICRONESIANS AS A WHOLE. BY IMPLICATION IF MARIANAS DISTRICT APPROVED NEW AGREEMENT WITH U.S. FOR PERMANENT ASSOCIATION IT WOULD THEN FEEL FREE TO BREAK AWAY, BUT NOT BEFORE. WARNKE SAID THAT HE WAS SOMEWHAT SURPRISED IN LIGHT OF THIS TO HEAR REPORT THAT PANGELINAN AND GUERRERO HAD SAID THEIR FUTURE ROLE IN JCFS WOULD BE THAT OF OBSERVERS ONLY.

3. ASSUMING WARNKE DESCRIPTION IN FACT REPRESENTS MARIANAS VIEW, THIS CLEARLY INDICATES CONTINUED ATTEMPT ON THEIR PART TO EAT THEIR CAKE AND HAVE IT TOO. THERE MAY BE A DEGREE OF GAMESMANSHIP INVOLVED AS WELL AIMED AT CREATING U.S. NERVOUSNESS AND PRESSURING US INTO GREATER CONCESSIONS DURING FORTHCOMING NEGOTIATIONS. WOULD ALSO EXPLAIN IN PART PANGELINAN'S RECENT INABILITY TO UNDERSTAND THINGS HE HAS BEEN TOLD BEFORE.
