4 Status is hereby directed to continue its negotiations with the
5 United States of America based on the guidelines set forth in
6 this Senate Joint Resolution; and

7 BE IT FURTHER RESOLVED that certified copies of this Senate
8 Joint Resolution be transmitted to the Chairman of the Joint Committee
9 on Future Status; to the President's Personal Representative for
10 Micronesian Status Negotiations; to the Secretary-General of the
11 United Nations; to the President of the United Nations Trusteeship
12 Council; to the President of the United Nations Security Council;
13 to the President of the United States; to the President of the United
14 States Senate; to the Speaker of the United States House of
15 Representatives; to the Secretary of the Interior; to the Secretary
16 of State; to the Secretary of Defense; and to the High Commissioner.
