1. PLANS ARE NOW FIRM FOR BEGINNING SUBSTANTIVE NEGOTIATIONS BETWEEN THE UNITED STATES GOVERNMENT AND REPRESENTATIVES OF THE PEOPLE OF THE MARIANA ISLANDS. THE U.S. DELEGATION WILL BE HEADED BY AMBASSADOR FRANKLIN HAYDN WILLIAMS AND THE MARIANAS POLITICAL STATUS COMMISSION HEADED BY SENATOR EDUARO PANGCELINAN.
2. FORMAL TALKS WILL BEGIN ON SAIPAN ON 15 MAY 1973. MOST MEMBERS OF THE U.S. DELEGATION WILL ARRIVE SAIPAN 15 MAY. HOWEVER, THEY WILL BE PRECEDED BY A SMALL ADVANCE PARTY, HEADED BY MR. JAMES M. WILSON, JR., U.S. DEPUTY REPRESENTATIVE FOR MICRONESIAN STATUS NEGOTIATIONS, THAT WILL ARRIVE SAIPAN ON 7 MAY 1973 FOR INFORMAL PRELIMINARY MEETINGS WITH THE MARIANAS DELEGATION BEGINNING 8 MAY 1973.
