GROUP STUDY ON THE NEGOTIATIONS ON THE FUTURE POLITICAL STATUS
THE MARIANA ISLANDS DISTRICT, TRUST TERRITORY OF THE PACIFIC
ISLANDS AND HAS ISSUED REVISED NEGOTIATING INSTRUCTIONS TO
AMBASSADOR WILLIAMS. THE REVISED INSTRUCTIONS ARE BEING TRANSMITTED
SEPARATELY BY OMSN.

2. BASED ON THE ABOVE, THE FOLLOWING CLASSIFIED DEFENSE INFORMATION
IN THE POSSESSION OF MEMBERS OF THE US NEGOTIATING TEAM (AS
MODIFIED BY THE REVISED NEGOTIATING INSTRUCTIONS BEING TRANSMITTED
SEPARATELY BY OMSN) MAY BE REGRADED UNCLASSIFIED AND RELEASED AS
NECESSARY AND AS AUTHORIZED BY AMBASSADOR WILLIAMS OR MR. WILSON
DURING THE PRELIMINARY MEETINGS OR FORMAL NEGOTIATIONS.
