FRENCH AND UK DELS COULD BE INSTRUCTED TO GIVE US POSITION
MORE SYMPATHETIC CONSIDERATION AT THIS DELICATE JUNCTURE.
IN OUR EFFORTS TO RESOLVE FUTURE POLITICAL STATUS OF TTPI,
REQUEST EMBASSIES ACCORDINGLY ALERT HOST GOVERNMENTS TO
OUR CONCERN OVER REPORT AND INFORM THEM THAT WE WOULD
LIKE TO PRESENT SUBSTANCE OF OUR OBJECTIONS TO CONTENTS
