1. DEPUTY PER REP ASHWIN INFORMED MISOFF JUNE 5 THAT, FOLLOWING US DELEGATIONS OPENING STATEMENTS JUNE 8, HE WILL INTRODUCE UNVM'S REPORT ON TTPI, ASHWIN SAID THAT IN HIS INTRODUCTORY REMARKS HE WOULD NOTE THAT REPORT BALANCES CRITICISM WITH PRAISE AND IS INTENDED TO HELP IMPROVE CONDITIONS IN TTPI.

2. ASHWIN ALSO SAID THAT IN HIS STATEMENT HE WILL ATTEMPT TO CORRECT THREE SPECIFIC ERRORS IN FUTURE STATUS CHAPTER OF REPORT. WITH REGARD TO STATEMENT IN PARAS 499 AND 500 THAT TALKS WITH COM WERE SUSPENDED IN OCTOBER 1972, ASHWIN WILL SAY THAT UNVM HAS SUBSEQUENTLY LEARNED THAT US SIDE DID IN FACT OFFER TO RESUME TALKS BUT THAT MICRONESIANS, BECAUSE OF ELECTIONS AND DEFEAT OF SOME MEMBERS OF JFSC, UNABLE TO DO SO. HE WILL ALSO NOTE RECENT WILLIAMS-SALII COMMUNIQUE. ASHWIN WILL, ALSO MODIFY STATEMENT IN PARA 514 THAT UNVM NOT GIVEN ANY INFORMATION ON US MILITARY'S LAND REQUIREMENTS FOR PALAU BY

ADMITTING THAT UNVM DID NOT SPECIFICALLY ASK FOR SUCH INFORMATION AND THAT US REQUIREMENTS MATTER OF PUBLIC RECORD. ASHWIN WILL ALSO HOPE THAT UNVM'S REFERENCE TO NAMIBIA IN CONTEXT OF COMMENT IN PARA 516 ON FRAGMENTATION OF TTPI WILL NOT BE INTERPRETED AS ATTEMPT TO DRAW ANALOGY BETWEFN TTPI AND SOUTH AFRICAN SITUATION.
