BASE, IS GIVING THE PEOPLE OF THE NORTHERN MARIANAS - RELATIVELY NEWCOMERS TO THE US SCENE - MUCH MORE THAN IT IS GIVING THE PEOPLE OF GUAM, PEOPLE WHO HAVE SERVED THE US LONG AND WELL FOR 75 YEARS." WHILE AGREEING WITH THIS VIEW, MURPHY DECLARED THAT "PEOPLE OF GUAM AND ITS LEADERS ESPECIALLY SHOULD BE SEVERELY CRITICIZED FOR NOT TAKING AN INITIATIVE IN REINTEGRATION OF THE MARIANAS MANY YEARS AGO."
