TRUSTESHIP COUNCIL JUNE 21 CIRCULATED AS COMMUNICATION (T/COM.10/L.110) LETTER DATED JUNE 15 FROM HERMAN HANGLONA, TINIAN REP IN MARIANAS DISTRICT LEGISLATURE AND MEMBER OF MARIANAS STATUS COMMISSION. LETTER, NOTING THAT TINIAN STUDENTS UNABLE TO ARRIVE IN NEW YORK IN TIME TO APPEAR AS PETITIONERS BEFORE CURRENT COUNCIL SESSION, TRANSMITS PETITION FROM OFFICE OF SPEAKER OF TINIAN MUNICIPAL GOVERNMENT SIGNED BY 176 TINIAN RESIDENTS, "WELCOMING THE ADMINISTERING AUTHORITY TO COME AND DEVELOP A MILITARY COMPLEX ON TINIAN ONLY ON TERMS AND CONDITIONS PRESCRIBED IN THE PETITION, IN ACCORDANCE WITH THE WISHES OF THE MAJORITY OF THE PEOPLE OF TINIAN."
