LEARNED YESTERDAY JULY 10 THAT TINIAN MUNICIPAL COUNCIL HAS BEFORE IT
PROPOSAL BY CONGRESSMAN FELIPE ATALIG WHICH WOULD CALL FOR REFERENDUM
ON TINIAN TO BE HELD SEPTEMBER 14, ACCORDING MY (U.S.) SOURCE, VOTERS
WOULD BE OFFERED THREE ALTERNATIVES: 1) NO MILITARY ON ISLAND, 2)
MILITARY PRESENCE WITH LIMITATIONS (PRESUMABLY SOMETHING SIMILAR TO
