(U) FOLLOWING MEMORANDUM SENT THIS DATE TO SERVICE SECRETARIES AND  
CJCS FOR ACTION, IS PASSED FOR YOUR INFORMATION:

QUOTE: DETAILED PLANNING FOR THE PROPOSED MULTI-SERVICE BASE  
DEVELOPMENT ON TINIAN NOW EXPECTED TO BE INITIATED IN AUGUST 1973,  
WILL REQUIRE FREQUENT VISITS BY MILITARY PLANNERS TO SAIPAN AND  
TINIAN. THIS MEMORANDUM PROVIDES GUIDANCE FOR SUCH VISITS. PARA.  
HEADQUARTERS, US AIR FORCE, AS EXECUTIVE AGENT, IS DEVELOPING THE  
TINIAN PROGRAMMING PLAN (NICKNAMED CRESTED ISLE) FOR APPROVAL BY  
THIS OFFICE. DOD PERSONNEL REQUIRED TO VISIT TINIAN OR SAIPAN AS A

RESULT OF ACTIONS DIRECTED BY THE FORTHCOMING PROGRAMMING PLAN ARE  
GRANTED APPROVAL TO TRAVEL IN ACCORDANCE WITH DOD DIRECTIVE 5000.7;  
HOWEVER, ALL DOD PERSONNEL SHALL CONFORM TO THE FOLLOWING ADDITIONAL  
PROCEDURES FOR EACH VISIT, A MINIMUM OF TWO WEEKS PRIOR TO THE  
SCHEDULED ARRIVAL ON TINIAN OR SAIPAN, IT IS REQUESTED THAT THE FOL-  
LOWING ADDRESSEES BE ADVISED ON THE PURPOSE AND SCOPE OF THE VISIT;  
THE NAME, RANK, SOCIAL SECURITY NUMBER, POSITION, AND SECURITY  
CLEARANCE OF THE PERSONNEL SCHEDULED FOR THE VISIT; AND THE PROPOSED  
ITINERARY. THE MESSAGE WILL BE ADDRESSED TO CINCPACREP TTPI/GUAM,  
AND STATUS LNO, HICOMTERPACIS SAIPAN. INFORMATION COPIES WILL BE

PROVIDED TO SECDEF, WASHINGTON, DC FOR ISA; CSAF FOR PRPO; OFFICE OF  
MICRONESIAN STATUS NEGOTIATIONS, C/O DEPARTMENT OF THE INTERIOR,  
WASHINGTON, DC; JCS(J-5); CINCPAC, CAMP H.M. SMITH, HAWAII FOR J-5;  
CINCPACFLT, MAKALAPA, HAWAII; AND CINCPACAF, HICKAM AFB HAWAII.

PARA. ALL VISITORS ARE REQUESTED TO PLAN THEIR ITINERARY TO INCLUDE  
THE FOLLOWING: A. BRIEFING BY THE LIAISON OFFICER, CINCPACREP  
TTRINQUAM AGANA, GUAM. BRIEFING WILL BE COMPLETED PRIOR TO ENTERING  
MARIANA ISLANDS DISTRICT. B. DISCUSSIONS WITH STATUS LIAISON OF-  
FICER (MISS MARY VANCE TRENT) ON SAIPAN PRIOR TO DISCUSSIONS WITH  
TRUST TERRITORY GOVERNMENT OFFICIALS AND MARIANAS REPRESENTATIVES.

DISCUSSIONS WILL INCLUDE POLITICAL AND PUBLIC RELATIONS GUIDANCE,  
PARA. THE PROPOSED VISIT MAY BE COMPLETED WITHOUT FURTHER CLEARANCE  
IN COMPLIANCE WITH THE GUIDANCE IN THE PARAGRAPHS ABOVE, OSD/ISA,  
CHIEF OF STAFF, US AIR FORCE (CSAF/PRP) AND CINCPAC CLEARANCE MAY BE  
ASSUMED, HOWEVER, IF POLITICAL OR LOGISTICAL SUPPORT CONSIDERATIONS  
REQUIRE A DELAY OR CANCELLATION OF THE VISIT, THE AGENCY PROPOSING  
THE VISIT WILL BE ADVISED PROMPTLY, THE EXECUTIVE AGENT, CSAF/PRP,  
WILL BE ADVISED BY THE REQUESTING AGENCY OF THE IMPACTS OF ANY  
DELAY OR CANCELLATION, PARA, CONTINUED ADHERENCE TO THE PROVISIONS  
OF DOD DIRECTIVE 5000.7 IS EXPECTED FOR TRAVEL INTO THE AREA NOT  
DIRECTLY RELATED TO THE TINIAN BASE DEVELOPMENT PROGRAM, UNQUOTE.
