THE OPENING OF THE SEVENTH ROUND OF STATUS NEGOTIATIONS BETWEEN AMBASSADOR F. HAYDN WILLIAMS AND THE CONGRESS OF MICRONESIA'S JOINT COMMITTEE ON FUTURE STATUS HAS BEEN POSTPONED FROM NOVEMBER 10 TO NOVEMBER 13. THE POSTPONEMENT OF A FEW DAYS WAS AGREED TO BY AMBASSADOR WILLIAMS AND SENATOR

SALII AT THE REQUEST OF THE LATTER IN A TELEPHONE CONVERSATION FROM SAIPAN TO SAN FRANCISCO ON THE MORNING OF FRIDAY, OCTOBER 26, 1973. THE POSTPONEMENT WILL GIVE MEMBERS OF THE JOINT COMMITTEE ADDITIONAL TIME FOR CONSULTATION AMONG THEMSELVES AND WITH THEIR LEGAL CONSULTANTS. (CREWMAN CHARGED)

SAIPAN, OCT. 26 (MNS) ---A YOUNG SAIPANESE CREWMAN ABOARD THE M/S GUNNER'S KNOT HAS BEEN CHARGED BY AUTHORITIES IN THE PHILIPPINES WITH "HOMOCIDE THROUGH RECKLESS IMPRUDENCE," ACCORDING TO INFORMATION RECEIVED THIS WEEK BY OFFICIALS OF TRANSPACIFIC LINES ON SAIPAN AND REPORTED BY KUOR NEWS.

TRANSPAC GENERAL MANAGER WILLIAM PENROSE SAID HE WAS NOTIFIED OF THE FORMAL FILING OF A CHARGE AGAINST 20-YEAR-OLD LUIS Q. KAPILEO IN A LETTER FROM HIS COMPANY'S AGENT IN MANILA, WHO IN TURN WAS INFORMED OF THE CHARGE BY WIRE FROM THE STATE'S ATTORNEY IN ILLIGAN, A SMALL TOWN ON THE ISLAND OF MINDANAO.

KAPILEO, OF TANAPAG VILLAGE ON SAIPAN, MAS TAKE INTO CUSTODY IN ILLIGAN LAST MONTH FOLLOWING THE APPARENTLY

(MAS MAULEG TO DRYDOCK)

SAIPAN, OCT. 26 (MNS) --- TRANSPACIFIC LINES ANNOUNCED FRIDAY (OCT. 26) THAT ITS SHORT-BANCE CARGO VESSEL M/S MA'S MAULEG WILL BE DUE FOR HER ANNUAL DRYDOCKING AND INSPECTION AT THE END OF OCTOBER. THE SHIP PRESENTLY SERVES THE TT PORTS OF PONAPE, KUSAIE, EBEYE AND MAJURO PROVIDING BOTH CARGO AND PASSENGER SERVICE.

A LETTER NOTIFYING TRANSPAC OF THE NEED FOR DRYDOCKING CAME FROM THE BOARD OF MARINE INSPECTORS OF THE TRUST TERRITORY GOVERNMENT. IT SAID:

"SINCE THE CERTIFICATE OF INSPECTION FOR MAS MAULEG HAS

EXPIRED, THE VESSEL HAS TO BE INSPECTED AND THE CERTIFICATE OF INSPECTION HAS TO BE RENEWED BEFORE SHE CAN CONTINUE OPERATING IN THE TERRITORIAL WATERS OF THE TRUST TERRITORY. THIS IS IN ACCORDANCE WITH THE PROVISIONS OF THE TRUST TERRITORY CODE..." TRANSPAC SAID CURRENT PLANS ARE TO WITHDRAW THE MAS

TRANSPAC SAID CURRENT PLANS ARE TO WITHDRAW THE MAS MAULEG FROM ITS CURRENT SERVICE AT THE END OF THE CURRENT-VOYAGE FROM MAJURO, EBEYE, KUSIAE AND PONAPE AND SEND HER TO THE SHIPYARD. "AT THE SHIPYARD," SAID GENERAL MANAGER OF THE COMPANY WILLIAM PENROSE, "WE WILL EVALUATE THE PROSPECTS OF RETURNING THE SHIP TO ITS PRESENT TRADE ROUTE AFTER OVERHAUL IN THE LIGHT OF THE EXPENSES OF MAINTAINING THE MAS MAULEG AND THE REVENUES GENERATED BY HER."

PENROSE SAID THAT IN THE MEANTIME SERVICE TO KUSAIE AND EBEYE WOULD BE PROVIDED BY THE OTHER SHIPS OF THE TRANSPAC FLEET, PARTICULARLY THE NEWLY ACQUIRED M/S HERKIMER AND M/S MUSKINGUM.

CLOSE LAST WEEK AFTER ALMOST THREE WEEKS OF NEETINGS IN KOROR. THE DISTRICT ADMINISTRATOR, THOMAS REMENSESAU, AND SPEAKER OF THE PALAU LEGISLATURE ITELBANG LUII DELIVERED SHORT REMARKS IN CLOSING THE SESSION, ACCORDING TO A REPORT FROM DISTRICT INFORMATION OFFICER DAVID NGIRMIDOL.

THE DISTRICT ADMINISTRATOR INFORMED THE LEADERS OF PALAU THAT THE BIDS FOR THE RENRAK BRIDGE WENT OVER THE EXPECTED FIGURE BY ABOUT TWO MILLION DOLLARS. HOWEVER, EVEN THOUGH THIS HAS CAUSED DELAY IN THE BUILDING OF THE BRIDGE, THE DISTAD ASSURED THE LEGISLATORS THAT THE BRIDGE WILL BE BUILT. HE WENT ON TO COMMENT ON THE NICE JOB DONE BY THE PALAU LEGISLATURE FOR THE PAST THREE WEEKS, AND SAID HE WILL CAREFULLY CONSIDER THE MEASURES THAT WILL BE SENT TO HIS OFFICE. BUT, HE SAID, SOME OF HIS ACTIONS MAY NOT SATISFY EVERYPODY. IN CONCLUDING HIS REMARKS, HE ASKED EVERYBODY TO THINK AND PRAY FOR THE TWO HIGH CHIEFS, IBEDUL AND REKLAI, THREE LEGISLATORS AND STAFF OF THE PALAU LEGISLATURE WHO ARE ATTENDING THE PACIFIC CONFERENCE OF LEGISLATORS IN SAMOA, SO THAT UPON THEIR SAFE RETURN, THE PALAUAN PEOPLE WILL BENEFIT FROM THEIR EXPERIENCE. BT

THE SPEAKER URGED HIS COLLEAGUES AND OTHER LEADERS OF PALAU TO COOPERATE AND WORK JOINTLY TOWARD THE FUTURE OF PALAU. HE FURTHER SAID THAT PALAU IS IN A STAGE WHERE WE MUST WORK TOGETHER FOR THE GOOD OF ALL OF US. "IT IS IN THIS ERA OF DEVELOPMENT," THE SPEAKER CONTINUED,"THAT WE MUST PUT OUR EFFORTS TOGETHER IN ORDER TO REACH OUR ULTIMATE POLITICAL DESTINY."

A TOTAL OF 59 MEASURES WERE INTRODUCED DURING THE SESSION, OF THESE 33 WERE RESOLUTIONS, AND 21 WERE ADOPTED. TWENTY-NINE

THE SUBCOMMITTEE CONSISTED OF SENATOR ROMAN TMETUCHL OF PALAU IN ADDITION TO CHAIRMAN PANGELINAN. THE SUBCOMMITTEE WAS ACCOMPANIED BY A TRUST TERRITORY HOSPITAL ADMINISTRATION SPECIALIST AND BY A CONGRESS OF MICRONESIA STAFF ATTORNEY. BT
