(EDUCATION FOR SELF-GOVERNMENT)

SAIPAN, NOV. 9 (MNS) --- THE NEW PROGRAM OF "EDUCATION FOR SELF-GOVERNMENT" RECENTLY ANNOUNCED BY THE HIGH COMMISSIONER IS NOW BEGINNING TO TAKE FORM, ACCORDING TO TT DIRECTOR OF PUBLIC AFFAIRS STRIK YOMA.

THE DECISION TO UNDERTAKE AN ACCELERATED PROGRAM OF EDUCATION FOR SELF-GOVERNMENT IN MICRONESIA WAS REACHED IN A MEETING HELD IN HONOLULU LAST MONTH BETWEEN AMBASSADOR FRANKLIN HAYDN WILLIAMS, PRESIDENT NIXON'S PERSONAL REPRESENTATIVE TO THE MICRONESIAN STATUS TALKS; CHAIRMAN LAZARUS SALII AND CO-CHAIRMAN EKPAP SILK OF THE CONGRESS OF MICRONESIA JOINT COMMITTEE ON FUTURE STATUS, DIRECTOR OF THE OFFICE OF TERRITORIAL AFFAIRS

STANLEY CARPENTER, AND HIGH COMMISSIONER EDWARD E. JOHNSTON.

IT WAS AGREED IN THAT MEETING THAT THE RESPONSIBILITY OF CONDUCTING AN EDUCATION FOR SELF-GOVERNMENT PROGRAM IN THE TRUST TERRITORY IS THE RESPONSIBILITY OF THE EXECUTIVE BRANCH OF THE TRUST TERRITORY GOVERNMENT.

FOLLOWING THE HONOLULU MEETING, TT DIRECTOR OF PUBLIC AFFAIRS STRIK YOMA HELD SEVERAL MEETINGS WITH TT DIRECTOR OF EDUCATION DAVID RAMARUI TO DISCUSS WAYS OF GETTING THE PROGRAM UNDERWAY. AS A RESULT OF THESE MEETINGS, KEY PERSONNEL FROM THE TWO DEPARTMENTS HAVE BEGUN THE NECESSARY TASX OF DRAFTING THE INITIAL PROGRAM PLAN WHICH WOULD BE SUBMITTED TO THE HIGH COMMISSIONER FOR APPROVAL.

"I WANT TO EMPHASIZE THAT THE SUCCESS OF THE PROGRAM IS VITALLY DEPENDENT UPON DISTRICT INPUTS NOT ONLY IN THE INITIAL PLANNING BUT ALSO IN THE DELIVERY OF THE SERVICE WHEN THE TIME COMES", YOMA SAID. "IN THIS CONNECTION, I HAVE BRIEFED THE DISTRICT ADMINISTRATORS WHO ARE CURRENTLY MEETING HERE ON SAIPAN ON ALL DEVELOPMENTS TO DATE, AND HAVE RECEIVED FROM THEM VALUABLE

ADVICE REGARDING THE IMPLEMENTATION OF THE PROGRAM", YOMA INDICATED THE INITIAL PLAN FOR THE PROGRAM OF EDUCATION FOR SELF-GOVERNMENT IN THE TRUST TERRITORY IS EXPECTED TO BE SUBMITTED

"I REGRET THAT I FIND IN ERROR THE STATEMENT MADE IN AN ARTICLE IN THE PACIFIC DAILY NEWS OF NOVEMBER 7 THAT LANDS WHICH THE U.S. HAS REQUESTED FOR MILITARY USE IN MICRONESIA WOULD NOT BE INCLUDED IN THE PROPOSED TRANSFER OF TITLE OF PUBLIC LANDS FROM THE TTPI ADMINISTRATION TO THE DISTRICTS IF SO REQUESTED." "TO THE CONTRARY, ALL OF THE LAND WHICH THE U.S. IS NEGOTIATING FOR ON KOROR AND EABELTHUAP, AND MOST OF IT ON

TINIAN, IS PRESENTLY CONSIDERED TO BE PUBLIC LAND AND IS INCLUDED IN THE DEFINITION OF LAND TO BE RETURNED TO DISTRICT CONTROL." "FURTHERMORE, THE STATEMENT THAT THESE LANDS WILL BE TURNED OVER TO THE U.S. MILITARY "WITHOUT EVER BECOMING MICRONESIAN PUBLIC LAND" IS WHOLLY INACCURATE SINCE THESE LANDS ARE BY DEFINITION ALREADY IN THE PUBLIC DOMAIN AND ARE PRESENTLY BEING HELD IN TRUST FOR THE PEOPLE OF MICRONESIA BY THE TTPI." "WHAT THE U.S. IS NOW SUGGESTING IS THAT IF REQUESTED TITLE

THE MARSHALLS SENATOR CONTINUED, "DESPITE OPPOSITION TO AND LACK OF COOPERATION FROM THE EXECUTIVE BRANCH OF THE TRUST TERRITORY GOVERNMENT SINCE ITS INCEPTION, THE MLSC HAS COME A LONG WAY TO UNTANGLE THE PROBLEMS WHICH SHOULD HAVE BEEN RESOLVED MANY YEARS AGO."

SENATOR KENDALL FURTHER STATED THAT HE HAS REVIEWED THE REASONS GIVEN IN SUPPORT OF HIGH COMMISSIONER JOHNSTON'S POSITION.
