1. UNGA 4TH (DECOLONIZATION) COMMITTEE DEC. 5 ADOPTED BY
OVERWHELMING VOTE (WITH US ABSTAINING) TWO RESES ON
SMALL NON-SELF-GOVERNING TERRITORIES, ONE DEALING WITH
CARIBBEAN (INCLUDING US VIRGIN ISLANDS) AND OTHER DEALING
WITH PACIFIC AND INDIAN OCEANS TERRITORIES (INCLUDING AMER-
ICAN SAMOA AND GUAM). BOTH RESES CONTAIN PREAMBULAR PARA-
GRAPHS "DEEPLY DEPLORING THE ATTITUDE OF THE ADMINIS-
TERING POWERS CONCERNED WHICH CONTINUE TO REFUSE TO ALLOW
UNITED NATIONS MISSIONS TO VISIT THE TERRITORY UNDER THEIR
ADMINISTRATION." BOTH RESES ALSO CONTAIN OPERATIVE PARA
WHICH "CALLS UPON US, AS ADMINISTERING POWER CONCERNED,
TO RECONSIDER ITS ATTITUDE TOWARDS RECEIVING OF UNITED
NATIONS VISITING MISSIONS."
